#### PART 1 – KEY INFORMATION

#### PURPOSE OF THE REPORT

To enable Cabinet to give consideration to the revised programme of meetings for the 2014/2015 Municipal Year.

#### **EXECUTIVE SUMMARY**

This report will enable Cabinet, as required by the Constitution, to submit for formal approval to the Annual Meeting of the Council, a programme of meetings for the 2014/2015 Municipal Year.

Cabinet, at its meeting held on 21 March 2014, recommended to Council for approval, the draft programme of meetings for the 2014/15 Municipal Year, subject to provision being added within to host meetings of the Standards Committee and the newly-established Local Plan Committee and Education and Skills Overview and Scrutiny Committee.

The programme of meetings, attached as an Appendix to this report, now includes set dates for meetings of the Education and Skills Committee, the Local Plan Committee and the Standards Committee.

### RECOMMENDATION

That the programme of meetings for the Council, the Audit Committee, the Community Leadership and Partnerships Committee, the Corporate Management Committee, the Council Tax Committee, the Education and Skills Committee, the Local Plan Committee, the Planning Committee, the Standards Committee and the Service Development and Delivery Committee, as set out in the Appendix to this report, be approved and be submitted to the Annual Meeting of the Council for formal approval.

#### **PART 2 – SUPPORTING INFORMATION**

#### **BACKGROUND**

A draft programme of meetings has been prepared and approved and is set out as an Appendix to this report. The meetings of the Corporate Management Committee, Community Leadership and Partnerships Committee and the Service Development and Delivery Committee will normally commence at 7.30 p.m. Meetings of the Planning Committee will normally commence at 6.00 p.m. Those Committees will normally meet at the Council Offices, Weeley. The commencement time and venue for meetings of the Community Leadership and Partnerships Committee may be subject to change on a meeting by meeting basis dependent on whether there is a need to assist representatives

of external organisations who are attending at the request of the Committee.

Meetings of the Audit Committee will be held on a quarterly basis at the Council Offices, Weeley and will normally commence at 7.30 p.m.

Public meetings of the Cabinet are scheduled to commence at 10.30 a.m. in the Essex Hall, at the Town Hall, Clacton-on-Sea.

Meetings of the full Council will commence at 7.30 p.m. and are scheduled to be held in the Princes Theatre at the Town Hall.

Members will note that meetings of the Human Resources Committee, the Licensing Committee and the Regulatory Committee will be arranged from time to time when required. Cabinet meetings are fixed by the Leader of the Council in accordance with Executive Procedure Rule 1.6 and therefore the scheduling et cetera may change.

The programme does not show meetings of the Sub-Committees, which are arranged either at meetings of the relevant Sub-Committee or from time to time when required.

There have been some minor changes made to the programme of meetings that was provisionally agreed at the Annual Meeting of the Council held on 7 May 2013. The Council meeting due to have been held on Tuesday 20 May 2014 has been moved back to Tuesday 3 June 2014 as the Princes Theatre is now required from 19 to 25 May 2014 for the receipt and opening of postal votes and the management of the verification and count in respect of the European Parliamentary Elections 2014. As a consequence the Service Development and Delivery Scrutiny Committee meeting provisionally arranged for Wednesday 21 May 2014 has been brought forward to Monday 19 May 2014.

The proposed date of the Annual Meeting of the Council in 2015 has been moved back from the usual first week in May to the fourth week in May as a result of the District Council Elections being held on Thursday 7 May 2015. This should also allow sufficient time for Members to sign their Declarations of Acceptance of Office; for political groups to be formed and registered; for a Widdicombe Review of Committee etc. seats to be carried out and for Group Leaders to then submit the names of their colleagues that they wish to sit on the individual Committees and Sub-Committees.

In addition, the formal Cabinet meeting provisionally arranged for 6 June 2014 has been moved back to 13 June 2014 to enable sufficient time for the Financial Outturn report to be produced.
