Decision Made:	To enter into a contract with CALFORDSEADEN LLP (company registration number OC315838) for the Carnarvon Terrace project which is being delivered as part of the wider Clacton Civic Quarter Levelling Up Fund scheme, and for the Homes in Dovercourt project, which is being delivered as part of the Dovercourt Town Centre Improvement Corridor scheme, for the provision of Mechanical, Electrical & Public Health (MEPH) Engineering services for both projects mentioned. The services have a total cost of £93,500 (Carnarvon Terrace) and £43,000 (Homes in Dovercourt) plus VAT.
Reason for Decision (if a report was produced to support the Decision, refer to or attach it):	On 6 October 2023 Cabinet considered a report titled 'Levelling Up Fund and Capital Regeneration Projects - Progressing the Projects to Planning Permission'.
