37. SOLAR FARMS AND THE EMERGING LOCAL PLAN

A.1 Solar Farms and the Emerging Local Plan

There was submitted a reference report by the Corporate Management Committee, which referred to a meeting of the Rural Projects Panel held on 13 May 2014, at which, the issue of solar farms within the context of the emerging Local Plan was discussed. The Panel requested that the Corporate Management Committee comment to Cabinet and the Local Plan Committee that this Council should be taking a robust, comprehensive approach to renewable energy within the Local Plan and, in particular, in pursuit of the following principles in relation to solar farms:

- (i) That solar farms should always be preferred on 'brownfield' or poor quality land and should only be permitted on 'best value' (i.e. Grade 1, 2 or 3a) land if the applicant had clearly demonstrated that a sequential test had been followed;
- (ii) That Tendring District Council and Essex County Council should encourage applications for solar farms on their own estates, on industrial areas and on public utility owned land; and
- (iii) That there should be guidance on preventing 'clustering' of solar farms in rural parishes or in close proximity to private property not part of the application.

The Corporate Management Committee, in supporting these principles added the words "and that such developments be at least a minimum of 250m from any dwelling or property" after the word "application" on line 3 to principle (iii) above.

Accordingly, it was moved by Councillor Guglielmi, seconder by Councillor McWilliams, and RESOLVED that the matter be referred to the Local Plan Committee and that when relevant reports are considered by that Committee, the comments and representations of the Rural Projects Panel and Corporate Management Committee be taken into consideration when considering these matters.

FREEHOLD DISPOSAL OF THE SHIP INN, KINGS QUAY STREET, HARWICH

A.2 Freehold Disposal of the Ship Inn, Kings Quay Street, Harwich

There was submitted a report by the Portfolio Holder for Regeneration, Inward Investment and Growth and Asset Management, which sought the Cabinet's approval to the freehold disposal of the Ship Inn, situated in Kings Quay Street, Harwich.

It was reported that the Council owned the premises, which had been let on a lease to a private tenant for some years. The Council, and current tenant, had both obtained independent valuations and the tenant had offered a price within the range that the Council's valuers considered to be best consideration reasonably obtainable, taking into account the existence of the lease and the position of the tenant as a special purchaser.

Accordingly, it was moved by Councillor Turner, seconded by Councillor Guglielmi, and RESOLVED that, subject to the Cabinet's decision on terms set out in the report at B.2 to the agenda, the freehold disposal of the Ship Inn, Kings Quay Street, Harwich, be authorised, in principle.
