#### PURPOSE OF THE REPORT

That the draft programme of meetings for the Council, the Audit Committee, the Community Leadership and Partnerships Committee, the Corporate Management Committee, the Council Tax Committee, the Planning Committee, the Service Development and Delivery Committee and the Standards Committee, as set out in the Appendix to this report, be approved and be submitted to the Annual Meeting of the Council for formal approval.

# **PART 2 – SUPPORTING INFORMATION**

### BACKGROUND

A draft programme of meetings has been prepared and approved by the Corporate Governance and Resources Portfolio Holder and is set out as an Appendix to this report. The meetings of the Corporate Management Committee, Community Leadership and Partnerships Committee and the Service Development and Delivery Committee will normally commence at 7.30 p.m. Meetings of the Planning Committee will normally commence at 7.00 p.m. Those Committees will normally meet at the Council Offices, Weeley. The commencement time and venue for meetings of the Community Leadership and Partnerships Committee will be subject to change on a meeting by meeting basis dependent on whether there is a need to assist representatives of external organisations who are attending at the request of the Committee.

Meetings of the Audit Committee will be held on a quarterly basis in the Connaught Room, at the Town Hall, Clacton-on-Sea. The Standards Committee will meet twice a year [March and September] in the Connaught Room (though other meetings may be arranged as required).

Public meetings of the Cabinet are scheduled to commence at 12 noon in the Essex Hall, at the Town Hall, Clacton-on-Sea.

Meetings of the full Council will commence at 7.30 p.m. and are scheduled to be held in the Princes Theatre at the Town Hall.

Members will note that meetings of the Human Resources Committee, the Licensing Committee, the Regulatory Committee and the Scrutiny Committee will be arranged from time to time when required. Cabinet meetings are fixed by the Executive Leader in accordance with Executive Procedure Rule 1.6 and therefore the scheduling et cetera may change.

The programme does not show meetings of the Sub-Committees, which are arranged either at meetings of the relevant Sub-Committee or from time to time when required.

At the request of the Head of Financial Services there have been a few minor changes made to the programme of meetings that was provisionally agreed at the Annual Meeting of the Council held on 4 May 2010. Cabinet will now meet on 10 August (instead of 3 August) and the Audit Committee will meet on 26 May (instead of 2 June) and 22 September (instead of 29 September). The October Council meeting has been brought forward to 20 October (from 27 October) to avoid clashing with school autumn half-term holiday.

In addition, at the request of the Chairman of the Planning Committee and the Interim Head of Planning Services, meetings of the Planning Committee (formerly the Development Control Committee) have been changed from a three-weekly cycle to a four-weekly cycle.
