PART 1 – KEY INFORMATION

PURPOSE OF THE REPORT

To enable Cabinet to give consideration to the programme of meetings for the 2012/2013 municipal year.

EXECUTIVE SUMMARY

This report will enable Cabinet to, as required by the Constitution, submit for formal approval to the Annual Meeting of the Council a draft programme of meetings for the 2012/2013 municipal year.

RECOMMENDATION

That the draft programme of meetings for the Council, the Audit Committee, the Community Leadership and Partnerships Committee, the Corporate Management Committee, the Council Tax Committee, the Planning Committee, the Service Development and Delivery Committee and the Standards Committee, as set out in the Appendix to this report, be approved and be submitted to the Annual Meeting of the Council for formal approval.

PART 2 – SUPPORTING INFORMATION

BACKGROUND

A draft programme of meetings has been prepared and approved and is set out as an Appendix to this report. The meetings of the Corporate Management Committee, Community Leadership and Partnerships Committee and the Service Development and Delivery Committee will normally commence at 7.30 p.m. Meetings of the Planning Committee will normally commence at 6.00 p.m. Those Committees will normally meet at the Council Offices, Weeley. The commencement time and venue for meetings of the Community Leadership and Partnerships Committee will be subject to change on a meeting by meeting basis dependent on whether there is a need to assist representatives of external organisations who are attending at the request of the Committee.

Meetings of the Audit Committee will be held on a quarterly basis in the Connaught Room, at the Town Hall, Clacton-on-Sea. The Standards Committee will meet twice a year [March and September] in the Connaught Room (though other meetings may be arranged as required).

Public meetings of the Cabinet are scheduled to commence at 12 noon in the Essex Hall, at the Town Hall. Clacton-on-Sea.

Meetings of the full Council will commence at 7.30 p.m. and are scheduled to be held in the Princes Theatre at the Town Hall.

Members will note that meetings of the Human Resources Committee, the Licensing Committee, the Regulatory Committee and the Scrutiny Committee will be arranged from time to time when required. Cabinet meetings are fixed by the Executive Leader in accordance with Executive Procedure Rule 1.6 and therefore the scheduling et cetera may change.

The programme does not show meetings of the Sub-Committees, which are arranged either at meetings of the relevant Sub-Committee or from time to time when required.

There have been a few minor changes made to the programme of meetings that was provisionally agreed at the Annual Meeting of the Council held on 17 May 2011. The full Council meeting provisionally arranged for 30 October 2012 has been deleted and as a result the Planning Committee due to have been held on Wednesday 31 October 2012 has been brought forward to Tuesday 30 October 2012 (as Tuesday is the usual meeting day for Planning Committee meetings). The Cabinet meeting due to have been held on 8 August 2012 has been deleted. The Cabinet meeting due to have been held on 31 October 2012 has been moved back to 7 November 2012 to avoid the Autumn Half-Term School Holidays.

The Audit Committee will now meet on Thursday 28 June 2012 (instead of Monday 25 June 2012) as a change in Regulations now means that the Committee no longer has to approve the draft Statement of Accounts in good time for them to be published by the deadline of 30 June (this is now delegated to the Chief Financial Officer). The opportunity has therefore been taken to move the meeting back to Thursday which is the usual meeting day for this Committee. The Audit Committee meeting on 24 May 2012 has been deleted and the Committee will move to four meetings per year. The Audit Committee meeting due to have been held on 20 September 2012 will now be held on 27 September 2012 at the request of the Head of Resource Management.

The Service Development and Delivery Committee will now meet on 11 June 2012 (instead of 4 June) as 4 June is now the Spring Bank Holiday (as part of Her Majesty The Queen's Diamond Jubilee celebrations – 5 June is also a Bank Holiday). In addition, the daytime meetings of the Corporate Management Committee scheduled for 27 and 28 September 2012 have been removed as that Committee will now scrutinise the Cabinet's Initial Financial Strategy proposals at an ordinary evening meeting.
