OUTSTANDING MOTIONS TO COUNCIL

(1) COUNCILLOR I J HENDERSON – SIZE OF THE COUNCIL'S EXECUTIVE

"Following the recent re-organisation of the Management Structure of the Council, and in order both to secure the alignment of the Executive with that structure and to achieve considerable financial savings, the Council requests the Leader of the Council, as soon as possible, to reduce the number of the Executive to no more than 5 Portfolio Holders (in addition to himself)."

Submitted to Council on 29 November 2011.

Considered at Cabinet on 14 December 2011 – Cabinet decided not to support original motion and put forward an alternative.

(2) COUNCILLOR P J OXLEY – FUTURE DELIVERY OF LEISURE PROVISION

"That this Council welcomes the Cabinet Decision made to call for a report on Leisure Services that Members had hoped would offer options on the future delivery of leisure provision in the Tendring area as well as a route map going forward.

Now the report has been completed the way forward appears to have been delayed, so in order to prioritise some action this Council instructs officers to prepare the detailed specification of the required level of service to allow for market testing of the service; to include the following key points:-

- 1. That the specification includes upgrading of Dovercourt Swimming Pool, Harwich Sports Hall and Frinton and Walton Swimming Pool.
- 2. Specification includes the present Leisure Centres (including joint use) with NO sites to close."

Submitted to Council on 29 November 2011.

Considered at Cabinet on 14 December 2011 – Cabinet decided to defer consideration of the motion until such time as the FSR of the Leisure Services function was completed.

(3) FORMER COUNCILLOR PAYNE – GRANTS TO THEATRES

"That this Council immediately releases from the relevant agreed budget for this year £50,000 to the Westcliff Theatre, Clacton and £20,000 for the Electric Palace, Harwich. And that the theatres in Manningtree and Frinton are approached to see if the remaining £10,000 can be utilised to aid them in improving the arts in their towns."

Submitted to Council on 1 July 2010.

Considered at Cabinet on 4 August 2010 – Cabinet decided to request proprietors of the theatres referred to in motion to identify extent to which the proposed grants could demonstrably contribute to achieving the Council's priorities. Those responses were to be brought before Cabinet when the Council's medium term financial position was clear so it could be considered in the context of the Council's overall financial position.

(4) COUNCILLOR D OXLEY – REDEVELOPMENT OF FRINTON & WALTON SWIMMING POOL, DOVERCOURT SWIMMING POOL AND HARWICH SPORTS HALL

"In accordance with the budget meeting in February 2010 this Council instructs officers to immediately proceed with the redevelopment of Frinton and Walton Swimming Pool, Dovercourt Swimming Pool and Harwich Sports Hall without delay."

Submitted to Council on 1 July 2010.

Considered at Cabinet on 4 August 2010 – Cabinet decided to defer for a report setting out business cases for the proposed redevelopments including how they would contribute to achieving the Council's corporate priorities. Again report was to be brought back when the Council's medium term financial position was clear etc.

(5) COUNCILLOR P J OXLEY – FREE SWIMMING PROGRAMME

"Council regrets the decision by the Government to abandon Free Swimming for the under 16's and over 60's from today (1st July). Council instructs officers to maintain the free swimming programme with funding from the Service Improvement Budget."

Submitted to Council on 1 July 2010.

Considered by Cabinet on 4 August 2010 – Cabinet decided to defer for a report to establish how free swimming for under 16s and over 60s would help achieve the Council's corporate priorities. Again report was to be submitted when the Council's medium term financial position became clear etc.

(6) FORMER COUNCILLOR PAYNE – 10P PARKING CHARGES AT MILTON ROAD CAR PARK, DOVERCOURT

"That this Council instructs that the 10 pence rate for the first hour parking at Milton Road Car Park Dovercourt, is reintroduced at the earliest possible time and by the very latest by the first week of June 2010."

Submitted to Council – 25 May 2010.

Considered by Cabinet on 16 June 2010 – Cabinet deferred for future report on how successful a trial free parking scheme had been (for upcoming period 30/9/10 to 31/5/11 on 7 car parks including Milton Road). Report would also consider use of S106 monies to subsidise free town centre parking.

(7) COUNCILLOR P J OXLEY – PROPOSED LEISURE CENTRE REDEVELOPMENTS (SAME THEME AS (4) ABOVE)

"That this Council reaffirms its commitment to the following Leisure Centre redevelopments and urges the present administration to start work on delivering these projects as soon as possible:-

- 1. The redevelopment of Frinton and Walton Swimming Pool, to include a new changing village and a 30 piece fitness facility as per the draft plans.
- 2. The redevelopment of Dovercourt Swimming Pool, to include a refurbished fitness suite, new pooling ceiling, new changing area, a lift and a new reception area.
- 3. The redevelopment of Harwich sports hall, to include a new fitness suite, a new dance studio and new changing facilities.

Finally, that this Council urges the present administration to submit a £1.2 million application for a learner pool in Dovercourt to Sport England as per the plans of the previous administration."

Submitted to Council – 27 May 2009

Considered by Cabinet on 10 June 2009 – Cabinet decided to defer for future report on how those projects would tie in with the Council's emerging Corporate Plan and priorities.

(8) COUNCILLOR S S MAYZES – INTRODUCTION OF A LEISURE LIFESTYLES CARD FOR DISABLED PEOPLE RECEIVING ALL TIERED PAYMENTS OF THE DISABILITY LIVING ALLOWANCE

"That this Council give due regard to disabled people by introducing a leisure lifestyles card specifically enabling disabled people access to an affordable and healthy lifestyle and that the card is for disabled people receiving all tiered payments of the Disability Living Allowance (DLA) and that it complies with the Disability Discrimination Act 2005".

Submitted to Council – 25 September 2007

Considered by Cabinet on 17 October 2007 – Cabinet decided to defer consideration for a further report.

(9) COUNCILLOR PATTEN – COMMISSIONING OF A REPORT BY SELECTED VOLUNTARY AND CHARITY SECTOR ORGANISATIONS INTO CURRENT YOUTH PROVISION IN TENDRING

"That this Council agrees with the Audit Commission's recommendations to embrace 'Commissioning', and as a first step commissions a report by selected Voluntary and Charity Sector organisations into current youth provision in Tendring and their potential role in solving the persistent challenges facing many of our young people, including the provision of professional youth work staff for sites such as the London Road multi-use-games-area, to enhance current services and help prevent potential problems for local residents".

Submitted to Council – 25 September 2007

Considered by Cabinet on 17 October 2007 – Cabinet decided to defer consideration for a further report.

(10) FORMER COUNCILLOR F A BAKER - PROPOSED ESTABLISHMENT OF A TRAINING AND ENTERPRISE CENTRE

"That Tendring District Council invite relevant local organisations and individuals to form a partnership with the express purpose of establishing a training and conference centre within this District."

Submitted to Council – 21 January 2003

Considered by Cabinet on 19 February 2003 – Cabinet decided to defer for then Regeneration Portfolio Holder to investigate and report further to a future meeting of the Cabinet.

(11) FORMER COUNCILLOR P A BEVAN – STOPPING PLACES FOR TRAVELLERS WITHIN THE DISTRICT

"Tendring District Council should seek a solution/various solutions, including the possibility of setting up suitable short term stopping places, to the ongoing problem caused by travellers taking up residence on unsuitable sites within the District. It should particularly seek to protect sensitive sites such as the area of land adjacent to Clacton Cemetery."

Submitted to Council – 8 October 2002

Considered by Cabinet – 6 and 20 November 2003 – Cabinet deferred for consultation with "interested parties"
