A.5 <u>BIG SOCIETY POSITION STATEMENT AND GOVERNANCE</u> (Report prepared by Gill Burden)

PART 1 – KEY INFORMATION

PURPOSE OF THE REPORT

To update Cabinet on the Big Society funding allocated to date and to outline opportunities to improve access by the community and the governance of the fund.

EXECUTIVE SUMMARY

- In February 2014, the Leader stated the Big Society Fund was to become more accessible to community groups and for it to be more transparent, more flexible and for it to involve genuine cross-party working.
- To widen community access to the Fund there will be additional representation sought for the existing Portfolio Holder Working Party. These will include a representative from Tendring District Association of Local Councils (TDALC), Community Voluntary Services Tendring (CVST) and Tendring Education Trust (TET).
- The Portfolio Holder for Finance and Transformation will Chair the Portfolio Working Party and will invite each political group leader to nominate a representative from their group to sit on the Working Party.
- The Big Society Fund currently requires projects to assist in delivering the Council's priorities to address education, aspiration and skills amongst young people or develop projects to enable more people to engage in sporting activities and physical activity. The current criteria will also require a project to be of substantial community benefit or provide a direct cost saving to the authority. This final requirement has proved difficult to meet and whilst any project able to demonstrate a cost saving would be welcomed, future applications will not be expected to meet it as a condition of funding.
- To date, the funding awarded has generated in excess of £1.26m of levered or in-kind funding creating a ratio of 4:1. For every £1 of Big Society funding awarded, the District has benefited by nearly an additional £4. Future projects will need to demonstrate they can achieve a similar return in order to be considered for approval.
- The Stage 1 application form will change to reflect the above and, taking account of feedback from previous applicants, will now allow for more flexibility on the number of words expected to describe the project outline and resources required to deliver it. A copy of the revised Stage 1 application is attached at Appendix A.
- Since April 201,1 there have been 167 applications received resulting in grant funding

of £355,797 being awarded to deliver a wide range of projects that have generated in excess of £1.26m of match funding in the form of either other funding secured by the projects or volunteer time attached to deliver the projects.

- The current Portfolio Working Party has met seven times since January 2013 and considered 26 applications and awarded funding to four of these.
- There is a summary of all applications awarded funding since April 2011 at Appendix B.

RECOMMENDATIONS

It is recommended:

- a) That Cabinet approve an increase in the membership of the Portfolio Holder Working Party that will assess and determine future applications to include a representative from Tendring District Association of Local Councils (TDALC) and Community Voluntary Services Tendring (CVST) and Tendring Education Trust (TET).
- b) That the Portfolio Holder for Finance and Transformation invites each political group leader to nominate a representative from their group to sit on the Working Party.
- c) That Cabinet agree applications no longer need to demonstrate a direct cost saving to the authority.

PART 2 – IMPLICATIONS OF THE DECISION

DELIVERING PRIORITIES

The Big Society funding supports projects that deliver the Corporate Goal to "*Help Children and Adults Achieve their Full Potential*" (Corporate Goal 3). In addition projects that receive funding will be assisting to deliver the priority from the Corporate Plan 2010 - 2016 to "*Ensure people have the knowledge and skills to secure good employment*".

FINANCE, OTHER RESOURCES AND RISK

Finance and other resources

The fund had a total allocation of £643,000 of which £287,203 remains unallocated.

The existing criteria appears to have had a negative impact on the number of applications received with just 19 being submitted in the current financial year resulting in four projects being awarded funding totalling £54,680.

Risk

There is a risk that funding allocated to any group or organisation is not spent appropriately or in accordance with the purpose for which it was given. Although controls are already in place to mitigate this risk through the processes in operation, the Portfolio Holder Working Party with cross council representation helps to bring enhanced scrutiny of the process providing increased transparency as to how funding is allocated.

LEGAL

There are no legal implications.

OTHER IMPLICATIONS

Consideration has been given to the implications of the proposed decision in respect of the following and any significant issues are set out below:

By reducing worklessness it is anticipated that the number of young people and adults who engage in unlawful behaviour will be reduced.

The actions set out have taken into account equality and diversity issues.

The actions will cover all wards.

BACKGROUND

The Big Society Fund was launched in April 2011 with £500,000 and a further £143,000 was allocated in March 2012. There have been 168 applications received and of these 24 have been awarded a total of £355,797 between them. There remains an uncommitted amount of £287,203.

The criteria initially asked that projects deliver a significant community benefit and ideally provide a direct cost saving to the authority. Since January 2013 project applications were also expected to assist in delivering the Council's priorities to address education, aspiration and skills amongst young people or enable more people to engage in sporting activities and physical activity. It is now proposed that projects are no longer required to meet the financial saving criteria as this has rarely been met and has been a barrier in most cases.

During the first year of the fund 2011/12 the fund received 117 applications, and funded 13 projects during 2012/13 there were 31 received of which 8 were funded and to date in 2013/14 there have been 19 received of which 4 have been funded.

Projects are expected to have applied to and successfully received funding from the most appropriate funder initially before applying to the Big Society fund as gap funding, therefore being a minority funder in most cases where there are national funding bodies such as the Football Foundation and Sport England.

The fund has made awards to 25 projects since the launch with the smallest being £240 and the largest £52,000 and generated in excess of £1.2m of match funding. This has been either the balance of the project costs or the value of volunteer time given to deliver the project. The full list is attached at Appendix B.

We will then assess the project to see that it is in line with the Council's objectives, is affordable and very importantly sustainable following which you will be notified as to whether you have been successful. Projects that are seeking general running costs are unlikely to be successful due to a lack of sustainability.

Applicants should note the more detailed Project Plans will need to show how you have consulted with the wider community and that it meets a local need and that there is community support for the project. Successful projects that receive funding will be required to submit monitoring reports showing how they are delivering on agreed performance indicators.
