REPORT OF THE PORTFOLIO HOLDER FOR COAST PROTECTION

A.6 PART - NIGHT STREET LIGHTING: PROPOSALS FROM THE WORKING PARTY AND NEW INFORMATION FROM ESSEX COUNTY COUNCIL

PART 1 – KEY INFORMATION

PURPOSE OF THE REPORT

To enable Cabinet to consider and note the findings and recommendations of the Part-Night Street Lighting Working Party which are to be reported to Full Council on 24 November.

To provide Cabinet with details of a letter from the Leader of the County Council to the Leader of Tendring District Council in which he sets out the conditions which would apply should the District Council decide to fund all or part restoration of night-time street lighting in the District and to enable Cabinet to decide what recommendation(s) it wishes to make to the Council in light of this new information.

EXECUTIVE SUMMARY

The Council decided, on 24 March 2015:

“That Tendring District Council requests Essex County Council to switch on street lights within the Tendring District at night to be funded from the £160,000 set aside within the 2014/2015 Fit for Purpose budget. Further, that the Leader of the Council and the Chief Executive be authorised to discuss the terms, including funding arrangements, with Essex County Council and bring proposals back to a meeting of full Council.”

Following this, on 7 July 2015, the Leader of the Council announced the formation of a Working Party, led by the Portfolio Holder for Coast Protection, to establish which parts of the District wished to have night time street lighting restored.

Findings of the Working Party

The Terms of Reference for the Working Party provide for it to identify those areas of the District where the predominant local view is that the lights should be switched back on at night-time and those where the view is that they should not.

All District Councillors and Town and Parish Councils have been asked to provide this information for their Ward or Parish and the responses are set out in Appendix A.

The Working Party met on 9 November 2015 to consider these responses and agreed that if the Council wishes to propose part on / part off lighting arrangements to the County Council then it would be preferable (and consistent with the majority of views expressed by Members / Town and Parish Councils) to submit a simple proposal based broadly on the lights in the main urban areas of Clacton and Harwich being switched back on and to remain switched off in the rest of the District.

The findings of the Working Party are to be submitted to the Full Council meeting on 24 November 2015. They have been included in this report to Cabinet for the sake of completeness because it is necessary to make Cabinet aware of the new information now provided by the County Council as set out in the letter from the Leader of Essex County Council.

Letter from Essex County Council

Attached as Appendix B to this report is a letter received from the Leader of Essex County Council (ECC) to the Leader of Tendring District Council (TDC), which states that any agreement to reinstate street lighting during the night will be subject to conditions which mean that the cost of any commitment would be in excess of the £160,000 set aside by the Council.

Having considered this report, the findings of the Working Party and the letter from ECC, the Cabinet is asked to determine whether it wishes to make a recommendation to Council as to how to proceed.

RECOMMENDATION(S)

It is recommended that :

- 1. Cabinet notes the recommendations to Council of the Part Night Street Lighting Working Party that if the Council wishes to obtain costings from the County Council to restore night time street lighting in Tendring for parts of the District but not others it should be on the following basis:-**

a. Lights to be switched back on all night for the following:-

- i. All Clacton, Jaywick and Holland on Sea wards namely Alton Park, Bockings Elm, Burrsville, Golf Green, Haven, Peter Bruff, Pier, Rush Green, St Bartholemews, St James, St Johns, St Marys and St Pauls.**
- ii. All Harwich, Dovercourt and Ramsey and Parkeston wards namely Harwich East, Harwich East Central, Harwich West, Harwich West Central and Ramsey and Parkeston.**
- iii. The ward of Brightlingsea.**
- iv. The Parish of Little Oakley.**

b. Lights to remain switched off at night for the following:

- i. All other wards of the Tendring District namely Alresford, Ardleigh and Little Bromley, Beaumont and Thorpe, Bradfield, Wrabness and Wix, Frinton, Great Bentley, Hamford, Holland and Kirby, Homelands, Lawford, Little Clacton and Weeley, Manningtree, Mistley, Little Bentley and Tendring, St Osyth and Point Clear, Thorrington, Frating, Elmstead and Great Bromley and Walton.**
- ii. The Parish of Great Oakley**

- 2. Following consideration of the recommendations of the Part Night Light Working Party and the letter from the Leader of Essex County Council, Cabinet determines whether to make a recommendation to Council.**

PART 2 – IMPLICATIONS OF THE DECISION

FINANCE, OTHER RESOURCES AND RISK

Finance and Other Resources

There is a one-off sum of £160,000 identified within the Council's 2014/15 Fit for Purpose Budget, to fund any costs for one year, pending a final decision on part-night street lighting by the Council.

ECC is prepared to consider, subject to conditions, switching the lights back on in certain areas within the district, as identified by this Council. The cost of doing so to Tendring District Council has not yet been established but it is clear that it will exceed the funds set aside as a result of the Council decision.

The Council must reduce its budget by £2million by 1 April 2016 and by at least a further £2million by 1 April 2017 with further future budget reductions expected after that.

Any decision to commit to funding part-night lighting will increase the savings which will have to be found from other TDC services.

LEGAL

The provision of street lighting is a County Council function and not a District Council function but it is within the powers of the Council to pay for additional street lighting to be provided by the County Council for all or part of the District should it choose to do so.

OTHER IMPLICATIONS

Consideration has been given to the implications of the proposed decision in respect of the following and any significant issues are set out below.

Crime and Disorder

From the responses received from Members and Town and Parish Councils, there is no hard evidence to suggest that having the street lights off during the night has had any significant adverse effects on the levels of crime and disorder within the district.

This view was echoed by the Police and Crime Commissioner for Essex, Mr Nick Alston, at a meeting of the Council's Community Leadership and Partnerships Committee, held on 26 October 2015.

Area or Wards Affected

The Members representing all wards have been consulted and those which have responded are shown in Appendix A to this report.

Consultation and Public Engagement

The findings within this report are as a direct result of responses received from Members and Town and Parish Councils within Tendring.

Details of previous public consultations in this regard, are set out in Appendix C.

PART 3 – SUPPORTING INFORMATION

BACKGROUND

The key milestones in the Council's consideration of the Part Night Street Lighting Issue are as follows

December 2013	The Council responded to the County Council's initial consultation on the detail of their proposals to cease night-time street lighting (between Midnight and 5am) with effect from January 2014. TDC had advertised the consultation and sought public contributions regarding which lights met the ECC criteria for being left on and these were incorporated into the TDC response.
25 November 2014	Council considered a motion for TDC to fund the lights being switched on for the remainder of the year and funding to be included in future years budgets until ECC reverse their decision. Motion referred to Cabinet.
12 December 2014	Cabinet considered the motion and requested that letters be sent to the County Council, Police /Fire/ Ambulance services, all Town and Parish Councils, and the AA seeking evidence of the impact of the cessation of night time street lighting. This consultation was subsequently widened to invite submissions from Members of the public. A summary of the responses to these letters and from the public is set out in Appendix C.
10 February 2015	£160,000 was set aside in the budget to meet the costs of restoring night-time street lighting. ECC announced that the period during which the lights would be switched off will be between 1am and 5 am from the end of March 2015.

The Cabinet's recommendations regarding the motion (initially considered on 25 November 2014) were considered on 24 March 2015. The decision of Council is set out under "Current Position" below.

CURRENT POSITION

The resolution by Council at its meeting held on 24 March 2015, was as follows:

"That Tendring District Council requests Essex County Council to switch on street lights within the Tendring District at night to be funded from the £160,000 set aside within the 2014/2015 Fit-for-Purpose Budget. Further, that the Leader of the Council and the Chief Executive be authorised to discuss the terms, including funding arrangements, with Essex County Council and bring proposals back to a meeting of full Council."

At its meeting held on 7 July 2015, the Leader of the Council, Councillor Stock, made a statement in respect of part-night street lighting to the effect that a cross-party, Portfolio Holder Working Party be set up to establish where in the District the predominant view was that the lights should be switched back on and where they should be left off.

The Working Party has met on two occasions (10 August and 12 October 2015) with a further meeting scheduled to be held on 9 November 2015.

At the first meeting on 10 August, the Working Party agreed its terms of reference and how it wished to gather the information required. This involved writing to all 60 Members and all Town and Parish Councils and, in order to promote a good response, each of the Working Party Members was allocated a number of Members and Town / Parish Councils to contact to encourage them to respond.

A summary of responses received by Members and Town and Parish Councils is attached as Appendix A to this report and, where appropriate this includes responses by Town and Parish Councils from the Spring 2015 consultation.

At the time of writing this report, 46 Members have responded.

The Working Party held its third and final meeting on Monday 9 November 2015 and received the responses set out in Appendix A.

It was of the view that a clear picture emerged of a desire in the main urban areas of Clacton and Harwich for the night time lighting to be switched back on and agreement that they should remain off in the rest of the District.

The Working Party felt that it would be better, more consistent and more likely to receive a prompt provision of costings by the County Council, if the proposal put forward was a relatively simple one with wards within urban areas either switched on or left off.

In the case of Brightlingsea, where an alternative proposal was put forward, the Working Party took the view that on the balance of comments from the Members and the Town Council the request should be for the lights to be on.

The Chairman of the Working Party has also agreed to include recommendations relating to the Parishes of Great and Little Oakley.

To conclude, the Working Party was of the view that if the Council asked to obtain costings from the County Council for a partial reintroduction of night time street lighting then it should be on the basis set out in Recommendation 1. of this report.

Conditions imposed by Essex County Council

Following the Council decision on 24 March 2015 the Leader of TDC, together with the Chief Executive met with the Leader of ECC to inform them of the Council's decision and, as per the Council decision, to discuss the potential terms and funding arrangements for lights to be switched back on. The discussion included the possibility of lighting in some areas being left on whilst left off in others, in accordance with the predominant public views.

The Leader of ECC undertook to look into the issue and whether a partial restoration of night-time lighting could be funded by TDC and to respond formally in due course. Following a reminder letter the County Council's formal response was submitted to TDC on 25 September 2015. A copy of the letter is set out in Appendix B.

The letter sets out four conditions which the County Council will impose in respect of any agreement which are as follows:

- Agreement to be for a period of four years;
- Payment to reflect cost of supplying energy and carbon related costs;
- Payment to be made on a quarterly basis;
- Notice of termination of agreement must be at least one year.

The requirement for any agreement to be for a four year period is the reason for bringing this report to Cabinet for consideration because the cost of any agreement will inevitably exceed the available budget.

The most recent estimate received from ECC is that the cost to TDC of restoring night-time street lighting across the District would be £147,000 per year.

Any decision by the Council to commit funding for a four year period (for any purpose) must be made in light of the fact that the Council must make ongoing savings of £2million to balance the budget for 2016/17 and at least a further £2million for 2017/18.

With this in mind Cabinet should consider whether it wishes to make any recommendations to Full Council as to whether the Council should proceed with the proposal to fund the restoration of night-time lighting and if so on what basis.

Thank you for your letter regarding street lighting on September 9, 2015. My apologies for the delay in responding to you.

My understanding of the deal that you may wish to do with us is to pay to keep the lights on in certain urban towns in Tendring, while keeping the lights off in rural areas where the policy has proved to be popular among residents.

I would kindly ask for you to write to me specifying the exact areas in Tendring that you would wish the lights to remain lit for the duration of the night. Once I have received this information, I will ask officers to analyse what the cost to Tendring District Council would be the areas you have specified.

Without this information, I am afraid I am not in a position to progress discussion on the specifics. However, in any deal we would be seeking to make would be based on the following terms:

- Agreement to be for a period of 4 years
- Payment to reflect cost of supplying energy, and carbon related costs
- Payment to be made on a quarterly basis
- Notice of termination of agreement must be at least one year

I would also like to take this opportunity to formally thank you for the collaboration and contribution you have been personally making to advance the devolution deal for Essex. Your insights have proved most valuable in the process and I welcome your role on the Leader's group on governance to progress work on the rules and structure of a Combined Authority.

I very much look forward to continuing our productive and close working relationship in the future.

RESPONSES TO REQUESTS FOR EVIDENCE AND PUBLIC COMMENTS SPRING 2015

Responses to the specific questions raised by Cabinet had been received from The AA, Essex County Fire and Rescue Services and Essex Police and from 14 Town and Parish Councils. The full responses were set out in the Appendices to item A.2 of the Report of the Leader of the Council to the meeting of the Cabinet held on 13 March 2015 and the main points were summarised as follows:

- *Essex County Fire and Rescue – no incidents reported and therefore no evidence to support the Service having encountered an occasion where inadequate lighting prevented crews from fulfilling their operational duties. All Service fire engines have significant lighting available and Essex County Council can be requested that lighting is switched on or remains on if required.*
- *The AA – primary concern is with the blackout on urban and suburban roads of 40mph or faster and they consider that the evidence for not switching lights off on these road is irrefutable. The AA hope that in the longer term more councils will install energy efficiency lighting as a way of reducing energy costs rather than a switch off.*
- *Essex Police – not aware of any current significant crime trends around the night time economy that could be driven by impact of lighting. Crime trends are monitored and if there is evidence of an increase in any particular type of crime action will be taken. This includes the ability to request Essex County Council to turn the lights on.*
- *Town and Parish Councils – most Town or Parish Councils have not reported receiving significant complaints or negative feedback regarding part night lighting. Harwich Town Council has reported a number of concerns expressed by residents. For some Councils, the effect is mitigated by them paying for lights themselves and there is concern, particularly in these Town and Parish Councils, about residents paying through council tax two or three times for street lighting.*

The Council was informed that there had been 309 responses received from individual residents to the online consultation. Of those, 203 had positively asked for the lights to be switched back on with a further 26 expressing concerns about the lights being turned off. The reasons cited included:

- *Generally feeling less safe in the dark;*
- *Fear of more crimes being committed especially burglary and vandalism. In the case of vandalism many people felt that there was increased damage to cars since the lights have been turned off. Several also mentioned that their fears around crime were exacerbated by concern that Clacton Police Station may close;*
- *Danger of falling on uneven pavements, kerbs etc.;*
- *Concern that emergency services would be unable to find the location of incidents in the dark and that criminals cannot be seen or identified in the dark;*

- *Concern that people out very early in the morning or late at night e.g. shift workers, partygoers etc. could be attacked;*
- *Not being able to see hazards whilst driving such as pedestrians, potholes etc.*

The Council was made aware that there were 67 respondents who had positively asked that the lights continued to be turned off between midnight and 5am. The reasons given were:

- *Better able to sleep at night without the glare from street lights;*
- *Ability to view the night sky and see the stars;*
- *There are benefits both financially and environmentally;*
- *The funding put aside to meet the cost of turning the lights back on could be better used e.g. more policing, social care, health;*
- *Turning off the lights discourages criminals as they cannot see in the dark either;*
- *Not wanting to pay two or three times for street lights to be on.*

Members were advised that the remaining respondents had not expressed a positive view one way or the other but had suggested alternative approaches that would still make cost savings but would allow the lights to be on, including installing LED lights or only turning off every second or third light.

It was also reported that information had also been received that the “We want our lights back on Tendring” campaign had secured approximately 10,500 signatures in favour of street lights being lit throughout the night and that the petition would be presented to ECC’s Highways Department once 14,000 signatures had been obtained.
