#### PART 2 - SUPPORTING INFORMATION

#### **BACKGROUND**

Further to minute 158 (A.2) of the meeting of the Cabinet held on 18 March 2016 a draft programme of meetings is set out as an Appendix to this report.

The meetings of the Corporate Management Committee, Community Leadership and Partnerships Committee and the Service Development and Delivery Committee will normally commence at 7.30 p.m. Meetings of the Planning Committee will normally commence at 6.00 p.m. Those Committees will normally meet at the Council Offices, Weeley. The commencement time and venue for meetings of the Community Leadership and Partnerships Committee <a href="may">may</a> be subject to change on a meeting by meeting basis dependent on whether there is a need to assist representatives of external organisations who are attending at the request of the Committee.

Meetings of the Audit Committee, the Licensing and Registration Committee and the Standards Committee will be held on a quarterly basis at the Council Offices, Weeley and will normally commence at 7.30 p.m. (with the exception of the Standards Committee which will meet at 10.00 a.m.). Local Plan Committee meetings will be held at 6.00 p.m. at the Council Offices, Weeley or in the Princes Theatre in the Town Hall, Clacton-on-Sea depending on the predicted public attendance.

Public meetings of the Cabinet are scheduled to commence at 10.30 a.m. in the Essex Hall, at the Town Hall, Clacton-on-Sea.

Meetings of the full Council will commence at 7.30 p.m. and are scheduled to be held in the Princes Theatre at the Town Hall.

Members will note that meetings of the Human Resources Committee will be arranged

from time to time when required. Cabinet meetings are fixed by the Leader of the Council in accordance with Cabinet Procedure Rule 1.1 and therefore the scheduling et cetera may change.

The programme does not show meetings of the Sub-Committees, which are arranged either at meetings of the relevant Sub-Committee or from time to time when required.

The Cabinet has proposed that a provisional meeting of Council be programmed for 29 November 2016 in case the Council does not get through all of the business on its agenda for its meeting on 22 November 2016 and that meeting has to be adjourned. If the provisional meeting does go ahead only the business left over from 22 November will be considered i.e. no new business will be transacted at that meeting. Members are advised that the Princes Theatre in the Town Hall is unavailable on any dates in late November and December due to a combination of the Christmas Pantomime and other meetings/events such as an NHS Board meeting. This means that the meeting on 29 November if it is required will be held in the Council Chamber, at the Council Offices, Weeley.

A provisional meeting of the Council has also been programmed for 24 January 2017 pending full Council's decision on Councillor Amos' motion to Council in respect of making the February meeting of full Council solely for the consideration of the Budget.

- 1. Annual Meetings of the Council moved forward from the usual first week in May to the fourth week in April as a result of the Police and Crime Commissioner Elections being held on Thursday 5 May 2016 and the Essex County Council Elections being held on 4 May 2017.
- 2. Meeting scheduled to be held on the Wednesday as a Council meeting is on the Tuesday of that week, and to enable political groups to hold pre-Council meetings on the Monday night.
- 3. Meeting scheduled to be held on the Wednesday as the Monday of that week is a Bank Holiday.
- 4. Tuesday meeting arranged to allow the Corporate Management Committee to consider the Cabinet's Financial Baseline and Initial Budget and Special Expenses Proposals. Thursday meeting arranged to allow the Committee to discuss those proposals with Portfolio Holders and senior Officers and then formally comment on those proposals to Cabinet.
- 5. Meeting of the Council to approve the Cabinet's budget proposals and set the Council Tax but excluding County, Fire and Police Council Tax calculations.
- 6. Provisional extra meeting of the Cabinet arranged in order to allow the Cabinet to meet and consider any objections the Council has to the Cabinet's budget proposals (which may have been made at the Council meeting on 7 February 2017).
- 7. Provisional extra meeting of the Council arranged in order to allow the Council to meet and consider the Cabinet's revised budget proposals or the Cabinet's disagreement with the Council's budget objections (which may arise from the Cabinet meeting referred to in note 6 above.)
- 8. Meeting to formally confirm the implications of the County, Fire and Police precepts on the Council's Collection Fund and for each Council Tax band in the parished and unparished areas of the District.
- 9. Meeting moved back from the usual Monday due to Easter Bank Holidays the previous weekend.

- 10. Audit Committee meeting moved back one week from provisionally agreed date of 23 June 2016 as this date is the date of the European Referendum.
- 11. Provisional meeting arranged in case the Council does not get through all of the business on its agenda for the 22 November 2016 meeting and the meeting is adjourned. If the provisional meeting does go ahead no new business will be transacted at that meeting.
- 12. Provisional meeting arranged pending Council's decision on Councillor Amos' motion to Council that the February meeting of Council be for consideration of the Budget only.
- 13. Special meeting of the Corporate Management Committee arranged to allow the Committee to consider and report back to Council on Councillor Amos' motion to Council that the February meeting of Council be for consideration of the Budget only.
