18. APOLOGIES FOR ABSENCE

19. MINUTES

21. REQUEST TO VARY THE OPENING HOURS OF A SEX ESTABLISHMENT LICENCE – THE ADULT CENTRE, 28 ORWELL ROAD, CLACTON ON SEA, ESSEX

The Sub-Committee considered an application from Miss Amanda Allen for the variation of the Sex Establishment Licence held in respect of the above premises.

The request was to vary the current opening hours of the existing Sex Establishment Licence in respect of the above premises to extend to 8.00 p.m. the opening hours on Mondays to Saturdays and to allow trading on Sundays. The current hours were from 10.00 a.m. to 7.00 p.m. on Mondays to Saturdays inclusive and not at all on Sundays and the variation requested was to allow trading on Mondays to Saturdays from 10.00 a.m. to 8.00 p.m. and Sundays from 10.00 a.m. to 4.00 p.m.

It was reported that consultation papers had been sent to Essex Police and the local Ward Councillors. At the time of the meeting no comments, objections or observations had been received from either of the afore-mentioned sources. Residents in the neighbourhood considered likely to be affected by the application had been consulted and no objections had been received by the date of the meeting.

Members were informed that the application had been displayed on the premises in the prescribed manner and a public notice inserted in a local newspaper as required by statute.

The Sub-Committee had before it, as set out in Appendix B to item A.2 of the Report of the Interim Head of Customer Services, those grounds which were material to the determination of such an application as set out in the Local Government (Miscellaneous Provisions) Act 1982.

The Sub-Committee was advised that the applicant had been invited to attend the meeting to put her case.

Miss Allen attended the meeting, spoke in support of the application and answered Members' questions.

22. <u>APPLICATION FOR THE RENEWAL OF A SEX ESTABLISHMENT LICENCE – PRIVATE SHOP, 28 ROSEMARY ROAD, CLACTON-ON-SEA</u>

The Sub-Committee considered an application from Darker Enterprises Limited for the renewal of a Licence to run a Sex Establishment at 28 Rosemary Road, Clacton-on-Sea. It was reported that the applicant proposed that trading would continue to take place from 10.00 a.m. to 7.00 p.m. on Mondays to Saturdays and 10.00 a.m. to 8.00 p.m. on Mondays to Saturdays from 13 December to 23 December inclusive and from 10.00 a.m. to 4.00 p.m. on Sundays.

The Sub-Committee was advised that the premises complied with the current conditions imposed, as set out in Appendix 'A' to item A.3 of the Report of the Interim Head of Customer Services.

It was further reported that consultation papers had been sent to Essex Police and the local Ward Councillors. At the time of the meeting no comments, objections or observations had been received from either of the afore-mentioned sources. Residents in the neighbourhood considered likely to be affected by the application had been consulted and no objections had been received by the date of the meeting.
