# 21. APPLICATION FOR THE RENEWAL OF A SEX ESTABLISHMENT LICENCE – PRIVATE SHOP, 28 ROSEMARY ROAD, CLACTON-ON-SEA

The Sub-Committee considered an application from Darker Enterprises Limited for the renewal of a licence to run a sex establishment at 28 Rosemary Road, Clacton-on-Sea.

It was reported that the Applicant had proposed that trading would continue to take place from 10.00 a.m. to 7.00 p.m. on Mondays to Saturdays, 10.00 a.m. to 4.00 p.m. on Sundays, and 10.00 a.m. to 8.00 p.m. on Mondays to Saturdays from 10 December to 22 December 2012 inclusive and not at all on Sundays.

The Sub-Committee was advised that the premises complied with the current conditions imposed, as set out in Appendix 'A' to item A.2 of the Report of the Head of Public Experience.

It was further reported that consultation papers had been sent to Essex Police and the local Ward Councillors and that at the time of the meeting, no comments, objections or observations had been received from either. Residents in the neighbourhood considered likely to be affected by the application had been consulted and no representations had been received.

Members were informed that the application had been displayed on the premises in the prescribed manner and that a public notice had been placed in a local newspaper to comply with the law.

The Sub-Committee had before it, as set out in Appendix 'B' of the afore-mentioned report, those grounds which were material to the determination of such an application as set out in the Local Government (Miscellaneous Provisions) Act 1982.

The Sub-Committee was advised that the Applicant had been invited to send representatives to attend the meeting. However, confirmation had been received that the Applicant would not attend, or be represented, but it was requested that the Sub-Committee consider the application in their absence, if possible.

It was moved by Councillor De-Vaux Balbirnie, seconded by Councillor Platt and:

**RESOLVED** that the application for the renewal of a Sex Establishment Licence for one year, in respect of Private Shop, 28 Rosemary Road, Clacton-on-Sea, be granted subject to the conditions as set out in Appendix 'A' to item A.2 of the Report of the Head of Public Experience.
