# 15. PLANNING APPLICATION 15/00679/FUL – LAND ADJACENT TO PUBLIC CAR PARK, CLACTON ROAD, ELMSTEAD, CO7 7DA

The Committee had before it the published Officer report containing the key planning issues, relevant planning policies, planning history, any response from consultees, written representations received and a recommendation of approval.

An update sheet was circulated to the Committee prior to the meeting with details of Parish Council and Highways Authority comments.

At the meeting, an oral presentation was made by the Council's Planning Team Leader (Minor Applications) in respect of the application.

Councillor Paul Beard, a local Parish Councillor, spoke against the application.

Mrs Clare Richmond, the agent on behalf of the applicant, spoke in support of the application.

Following consideration by the Committee, it was moved by Councillor Nicholls, seconded by Councillor Watson and **RESOLVED** that the application be deferred to allow Officers to negotiate and clarify on the following points:

- Cramped appearance of plots one and two
- Surface water drainage and culverting of existing ditches
- Accesses on to A133 and lack of footpath
- Capacity of AWS pumping station

### 16. PLANNING APPLICATION 15/00675/OUT – LAND OFF CLACTON ROAD, ELMSTEAD CO7 7DB

The Committee had before it the published Officer report containing the key planning issues, relevant planning policies, planning history, any response from consultees, written representations received and a recommendation of approval.

An update sheet was circulated to the Committee prior to the meeting with details of a comment received from the Council's Regeneration Team and an appeal decision that affected the application.

At the meeting, an oral presentation was made by the Council's Planning Policy Manager in respect of the application.

Councillor Paul Beard, a local Parish Councillor, spoke against the application.

Mr Patrick Stroud, the agent on behalf of the applicant, spoke in support of the application.

Following discussion by the Committee, it was moved by Councillor Nicholls, seconded by Councillor Raby and **RESOLVED** that the Head of Planning be authorised to refuse the application for the following reasons:

"It is contrary to NPPF paragraphs 7 and 9 and Local Plan policies QL1; SD3; SD5; EN1; QL9; PLA5; QL11; and SD9 in so far as the adverse environmental impacts of the development do not outweigh the benefits of the scheme and would not be of a fair and proportionate scale having an urbanising impact on the rural surroundings."

The Committee also requested an informative be sent to the applicant to explain that a Section 106 agreement would be required.
