## 7.0 RELEVANT REPRESENTATIONS

#### 7.1 **Responsible Authorities**

A representation was received from the Department of Public Experience (Food, Health & Safety), on the grounds that the Licensing Objectives in respect of Public Nuisance had not been satisfied. However, following discussions with the Applicant, this representation has been withdrawn, subject to the following conditions being attached to the Licence:-

- 1. All external doors shall be kept closed, except for access and egress during the provision of regulated entertainment, being a condition relating to the prevention of public nuisance.
- 2. The holder of the premises licence or any other person in control of the premises shall undertake routine monitoring to ensure external levels of music are not excessive and take appropriate action where necessary.

# 7.2 Interested Parties

One letter and one petition of representation have been received from local residents on the grounds of public nuisance and noise nuisance.

# 8.0 POLICY CONSIDERATIONS

The Licensing Authority's Statement of Licensing Policy expects applicants to demonstrate in their Operating Schedule that suitable and sufficient measures have been identified and will be implemented and maintained to prevent public nuisance relevant to the individual style and characteristics of their premises.
