### JOINT USE SPORTS FACILITIES UPDATE – ADDENDUM TO FULL REPORT

#### PART 1 – KEY INFORMATION

##### PURPOSE OF THE REPORT

To provide supplementary information to the Resources and Services Committee in addition to the report already published on the Joint Use Sports Facilities, in advance of the next meeting on 14 March 2022.

##### EXECUTIVE SUMMARY

*In addition to the full report the committee should note that:*

The public had an opportunity to express their views on the joint use facilities in Brightlingsea at a public meeting held on 9 March 8.00pm, which filled the hall in Brightlingsea Community Centre, and was hosted by the Town Council. Attendees raised a number of points, including:

- A show of hands indicated that there were a number of gym users in attendance, who expressed concern at the closure of the gym at the end of the month. The data on usage shows under 800 attendances of the fitness suite in 2019.
- Two difficulties with booking operations were highlighted. One was accommodating a small number of bookers later into the evening and at weekends. Options for extending opening hours to meet this demand are proposed and a discussion held with one group still seeking to find a booking. The other was the operation of the booking system. It is recognised that during the transition as groups move over from the District Council to the Sigma Trust, the booking processes requires refining. An on line booking system from the Sigma Trust is scheduled to be available from 1 April.
- Non group activities. Without the formation of a club, attendees who used the facilities on a casual basis without booking through a club, for example playing table tennis, would not be able to use the facilities after the transition period ended. The difficulty for those without access to a car to drive to the facilities in Clacton or Colchester was highlighted.

Two additional decisions were made by Cabinet regarding the development of the leisure and sport offer across the district and involvement of the Resources and Services Overview and Scrutiny Committee to provide input into this work. This will provide the platform for how the Council develops its Sports and Activities offer around the District over the lifetime of the strategy.

Initial consultation took place with both Brightlingsea and Harwich Town Councils, to establish their opinions and whether they would consider future involvement in the operation of BSC and HSC respectively confirmed both organisations were open to discuss future involvement. To date respective Town Councils have not expressed a wish to explore the feasibility of operating BSC and HSC respectively. Brightlingsea Town Council have indicated they have secured the services of a professional consultant to support suggestions on future operation of the facility. It is understood this work has commenced.

Officers are holding discussions with other individuals and organisations, together with the Sigma Trust, with regards to proposals for how parts of the facilities could be operated following the end of the transition period. These conversations are ongoing.
