PURPOSE OF THE REPORT

EXECUTIVE SUMMARY

This report sets out a motion submitted by Councillor Pemberton to the meeting of the Council held on 15 May 2018 relating to an additional flag raising day at the Town Hall and which was referred to the Committee by the Chairman of the Council for consideration and report, in accordance with the provisions of Council Procedure Rule 12.4.

PART 2 – SUPPORTING INFORMATION

BACKGROUND

At a meeting of the Council held on 15 May 2018, the following motion was moved by Councillor Pemberton and seconded by Councillor Porter and, in accordance with Council Procedure Rule 12.4, stood referred to the Committee for consideration and report:

“That this Council approves that, in addition to Armed Forces Day, Merchant Navy Day and Commonwealth Day, St George’s Day be added as a flag raising day at the Town Hall and that the national flag of England be flown on that day.”

CURRENT POSITION

In accordance with Council Procedure Rule 12.5 Councillor Pemberton has been invited to attend the meeting and explain the motion.

For Members information the Council currently raises flags for Armed Forces Day,

Merchant Navy Day and Commonwealth Day. The Council is invited by the Ministry of Defence, Seafarers UK and The Commonwealth Pageantmaster respectively each year to raise these flags and the Council accepts the invitation to take part in these nationwide events. The Council also receives guidance from the Ministry of Housing, Communities and Local Government about occasions when flags should be flown at full or half mast. At present the Council does not raise any flags based on a local policy decision so consideration may need to be given to the parameters of local flag raising when considering this motion.

PART 1 – KEY INFORMATION

PURPOSE OF THE REPORT

EXECUTIVE SUMMARY

- At Council on 24 April a work programmes for the new Community Leadership Overview and Scrutiny Committee was agreed.
- As the Community Leadership Overview and Scrutiny Committee is a new Committee the main agenda item for the meeting on 4 June was agreed as “opportunity for the new Committee members to refine the Work Programme and agree on the Task and Finish Group topics, scope and membership.”
- An informal meeting of the committee members was held on 11 May to give some consideration to possible task and finish topics. The final topics and membership need to be formally considered and agreed by the Committee. Not all members of the Committee were able to attend the informal meeting. Details of the informal discussions are set out in the background section of the report.
- At Council on 15 May a motion was referred to the Committee for consideration in relation to flying the St George’s flag on St George’s Day. The covering report for this item is included elsewhere on this agenda.
- An item to review the recent road rally in Tendring was previously included on the Work Programme of the Resources and Services Overview and Scrutiny Committee. However, it has been ruled that this item should be considered by the Community Leadership Overview and Scrutiny Committee as the Council was not the organiser for this event. It is suggested that rather than be a single agenda item, this forms the basis of a task and finish topic.
- The Committee needs to determine:-
 - The topics and scope of the focussed task and finish groups; and
 - The membership of each task and finish group.
- The Work Programme for 2018/19, including the reference from Council, is attached at Appendix A. The Committee is asked to consider whether it has any further amendments to this Work Programme

RECOMMENDATION(S)

It is recommended that:

a) The Committee agrees:-

i. The topics and scope of the focussed task and finish groups; and

ii. The membership of each task and finish group.

b) The Committee determines whether it has any further changes to the Work Programme attached at Appendix A.

BACKGROUND

An informal meeting of the committee members was held on 11 May to give some consideration to possible task and finish topics. The final topics and membership need to be formally considered and agreed by the Committee. Not all members of the Committee were able to attend the informal meeting. However, to inform the formal discussion the essence of the informal consideration is set out below.
