# 31. REPORT OF THE CORPORATE DIRECTOR (OPERATIONS AND DELIVERY) A.1 - APPLICATION FOR THE GRANT OF A PREMISES LICENSE - OAKMEAD SOCIAL CLUB, OAKMEAD ROAD, ST OSYTH, CO16 8NW

The Chairman (Councillor Winfield) welcomed everyone to the meeting and made introductory remarks.

The Council's Temporary Licensing Manager (Michael Cook) then gave a verbal summary of the written report and advised that the Sub-Committee had before it, for its consideration, as set out in item A.1 of the Report of the Corporate Director (Operations and Delivery), an application for the grant of a Premises Licence in respect of Oakmead Social Club, Oakmead Road, St Osyth, CO16 8NW.

This application was made under the Licensing Act 2003 for a Premises Licence to include indoor sporting events, live music, recorded music, late night refreshment and the sale of alcohol on the premises.

The premises was a bar and Chinese restaurant, with smoking area, beer garden and large car park. Situated off the main road in a residential area.

Section 2.2 of the written report set out the proposed opening hours of the premises which were:-

Sundays to Thursday 1200 to 0000 Fridays and Saturdays 1200 to 0200

## STEPS THAT APPLICANTS PROPOSED TO TAKE TO PROMOTE THE LICENSING OBJECTIVES WITHIN THEIR OPERATING SCHEDULE

The applicant stated the following steps in the application to promote the licensing objectives. These measures were reproduced as shown in the application form and are detailed below for ease of reference. These were:

#### **Crime and Disorder**

Premises and outside areas are monitored by CCTV. Any suspicious activity will be reported to the Police.

#### **Public Safety**

Premises and outside areas are monitored by CCTV. Appropriate fire safety is in place with regard to exits and fire control equipment. First Aid equipment is available on the premises.

#### **Prevention of Public Nuisance**

Noise from any live or recorded music will be contained within the premises which has double glazed windows and a lobby.

When drinking in the beer garden, customers will be monitored on noise level.

#### **Protection of Children from Harm**

Children with only responsible adults will be admitted to the premises.

No alcohol will be sold to under 18 year olds and proof of age will be asked for when appropriate.

When children are present appropriate language and behaviour will be expected and monitored from other customers.

General Information in support of the application in relation to all of the licensing objectives.

Staff are aware of contacts to be made in case of any emergencies. Staff will be instructed and made aware of other steps listed.

21 letters of representations/objections and 2 letters of support were received.

As standards procedure, all relevant authorities were consulted. No representations were received from any other Responsible Authorities.

The following papers were attached as part of the agenda for Members of the Sub-Committee only:-

- (i) Application form and any supporting documentation.
- (ii) Location Plan.
- (iii) Representation/objection letters

Copies of all documentation concerning this application were also available from Licensing Section upon request.

The applicant advised the Committee that previously, a customer was charged for an offence relating to Anti-Social Behaviour. Various items were destroyed. Ms Kung advised most customers are elderly. Complaints were received regarding litter, the applicant advised that the litter from passers-by is regularly cleared and disposed of. The license was to extend the premises opening hours.

Councillor Henderson asked what the relationship with residents was like. Ms Kung advised relationships were friendly with the exception of the individual in which she explains above.

A resident read a letter in support of the application.

Councillor Winfield asked if the premises advertised the legal age in which alcohol would be sold. The representative of the applicant confirmed that 18 years of age was the legal age to drink alcohol in the premises.

Councillor Davis acknowledged the letters of objection received. The letters exercised the 2am finish. Councillor Davis suggested making the provision to apply for a special licences when late openings are required.

The applicant's representative asked whether there would be a compromise in the Committees decision to potentially close the premises at 1200hrs.

A resident, on behalf of St Osyth Parish Council read a letter against the application.

Councillor John White, on behalf of St Osyth Parish Council spoke in support of the application.

The applicant advised that a decision to extend opening hours to 12am would be suitable.

#### 32. ADJOURNMENT OF MEETING

The meeting was adjourned whilst the Sub-Committee made its deliberations.

# 33. REPORT OF THE CORPORATE DIRECTOR (OPERATIONS AND DELIVERY) A.1 - APPLICATION FOR THE GRANT OF A PREMISES LICENSE - OAKMEAD SOCIAL CLUB, OAKMEAD ROAD, ST OSYTH, CO16 8NW

After a period of time, the Sub-Committee, the Council's Solicitor and the Leadership Support Officer returned to the meeting.

The Chairman read the following statement:-

- The Sub-Committee gave careful consideration to this application. In reaching
  their decision, they took into account the views expressed by the applicant, the
  representations received from residents and the Parish Council and the
  Resident's Association along with Guidance issued by the Secretary of State and
  other matters set out in the Licensing Authority's own Statement of Licensing
  Policy.
  - The Sub-Committee **DID NOT AGREE** to grant the application in full but agrees to the sale of alcohol on the premises and late refreshments until 0000 Mondays to Sundays, in relation to Indoor Sporting Events, Live and Recorded Music, these were agreed as the applicant asked for. The Sub-Committee noted what the application said about her previous record and the issues in the last year were primarily down to a tenant that she had let the premises to. However, the running of the Social Club is still this applicant's responsibility.
- 2. Whilst the Sub-Committee accept that the applicant would not be responsible for littering the area around the premises, she was to encourage people to dispose of little in receptacles around the premises or to take it home to safely dispose of, and also to undertake regular little picks around the exterior of the premises to improve the area for all.
- 3. If residents have any concerns in the future with reference to Anti-Social Behaviour and noise to contact the Licensing Team.

Finally, the Chairman advised that all parties who were aggrieved at the decision of the Sub-Committee, they have the right of appeal to the Magistrates' Court.

The decision was made today, 14 June 2021 and would be confirmed in writing to all parties.

#### The Licensing Committee officers and their roles

- The Committee Clerk (Democratic Services Officer) records the proceedings;
- The Legal Advisor provides independent advice to the Committee Members on legal matters; and
- The Licensing Officer introduces the matter, outlines the application or review as set out in the Report, and answers any questions Members may have.

#### **Committee Members (Councillors):**

Members have a responsibility to declare interests, those who declare **Discloseable Pecuniary Interest** (DPI) as defined by The Relevant Authorities (DPI) Regulations
2012 must not take part in the hearing of the application.

If a Member declares a **Pecuniary or Non-Pecuniary Interests**, as defined by Tendring District Council's Members' Code of Conduct (paragraphs 5 and 6), they must consider the impact of that interest on participation and the public perception;

- Matters for Members to consider would cover, but not exclusively:
  - they know the applicant or any of the objectors; or
  - they wish either to support or oppose the granting or continuation of a licence either personally or on behalf of their constituents.
  - whether they have expressed a view on the application site especially, if situated either in their ward or an adjacent ward;

#### Other Persons or Interested Parties:

This is the term given to an individual, body or business or a representative acting on their behalf-that raises an objection or make a representation to an application for a premises/personal licence. It should be noted that only the Police can make a representation against a Personal Licence application however. These other persons or interested parties are separate to Responsible Authorities, who may also be a party to the hearing.

#### **PROCEDURE**

THESE SUB-COMMITTEES MEETINGS & THE HEARING ARE HELD IN PUBLIC, UNLESS THERE IS A LEGAL REASON NOT TO DO SO, HOWEVER THESE ARE IN LIMITED CIRCUMSTANCES.



#### REPORT OF CORPORATE DIRECTOR [OPERATIONS AND DELIVERY]

#### LICENSING ACT 2003

Members are respectfully reminded that, in determining the matters listed under item A.1, they are exercising an administrative function but should determine each matter adopting the civil burden of proof, i.e. 'on the balance of probabilities'. The matters will be determined on the facts before the Sub-Committee and the rules of natural justice will apply. Each application must be considered in its own right and on its own merits.

#### **Premises Licence Applications**

The Licensing Act 2003 established a single integrated scheme for licensing premises that are used for the supply of alcohol, regulated entertainment or provision of late night refreshment. This system of licensing incorporates the sale of alcohol both on and off licensed premises; public entertainment such as music, dancing, indoor sporting events, boxing or wrestling, theatres, cinemas; and late night refreshment houses and take-aways.

The purpose of the licensing system is to positively promote the four 'licensing objectives'.

#### These are:

- The Prevention of Crime and Disorder
- The Prevention of Public Nuisance
- Public Safety
- The Protection of Children from Harm.

The options open to the Sub-Committee when considering this application are:

- To grant the application for a premises licence subject to such conditions that are consistent with the operating schedule accompanying the application and any mandatory conditions applicable.
- 2. To grant the application for the premises licence subject to such conditions as are consistent with the operating schedule accompanying the application and which are modified to such an extent as the Sub Committee considers appropriate for the promotion of the licensing objectives, and any mandatory conditions applicable.
- 3. To grant the licence as above, but to exclude from the scope of the premises licence any of the licensable activities to which the application relates.
- 4. To reject the application

When determining the application with a view to promoting the licensing objectives in the overall interests of the local community the Licensing Authority in the form of the Licensing Sub-Committee must have regard and give appropriate weight to the following:

- Full Hearing Procedure for Applications for Premises Licences/Club Premises Certificates where representations have been received.
- Tendring District Council's Statement of Licensing Policy.
- The Statutory Guidance issued by the Secretary of State under Section 182 of the Licensing Act 2003.
- The steps appropriate to positively promote the four 'Licensing Objectives'.
- Representations (including supporting information) presented by all the parties.

#### **Human Rights Implications**

A Licence is to be regarded as the property of the applicant; however their right to the use of the property must be balanced against all other public interests or representations in this matter that the Premises/Personal Licences Sub-Committee may wish to consider as appropriate, reasonable and proportionate in relation to the application that has been submitted and also the representation/s that has/have been received against it.

In making their decision as to whether to grant this application, Members of the Premises/Personal Licences Sub-Committee should also take into consideration Article 1 of the First Protocol of the Human Rights Act 1998, that individuals are entitled to the peaceful enjoyment of their property, and also Article 8 that everyone has the right to respect for his private and family life and his correspondence.

#### **Crime and Disorder Implications**

Section 17 of the Crime and Disorder Act 1998 imposes a duty on local authorities when exercising any of their functions to have due regard to the likely effect of the exercise of those functions on, and the need to do all it possibly can to prevent, crime and disorder in its area.

## 4.0 STEPS THAT APPLICANTS PROPOSE TO TAKE TO PROMOTE THE LICENSING OBJECTIVES WITHIN THEIR OPERATING SCHEDULE

The applicant has stated the following steps in the application to promote the licensing objectives. These measures are reproduced as shown in the application form and are detailed below for ease of reference. These are:

#### 4.1 Crime and Disorder

- The site currently operates an in-house no re-entry policy.
- The times this will be no re-entry after 10pm Monday Thursday and 9pm Sunday.
- No re-entry for new customers past 11pm on a Friday and Saturday night.
- CCTV system in place.

#### 4.2 Public Safety

- CCTV system in place.
- During these restrictions everyone must electronically sign in through NHS app (or proof of ID ie, driver's licence etc.)
- The site operates a firm and robust anti-drug and anti-social behaviour policy at all times.

This includes monitoring the exterior of the Premises and will refuse entry/service when needed.

#### 4.3 Prevention of Public Nuisance

- Customers asked to leave quietly, and respect neighbours signage placed around the premises
- The site only allows background music at a reduced level after 11pm during the week and 12 midnight Friday and Saturday.

#### 4.4 Protection of Children from Harm

 The site operates a strict all under 18 policy (must be accompanied by a responsible adult) and the responsible adult must remain sober, also no under 18 after 8pm daily.

## 4.5 General Information in support of the application in relation to all of the licensing objectives.

- The application is to request an increase of licensing hours for sale of alcohol on a Friday and Saturday night.
- The tenant/DPS and staff members have worked hard through the pandemic problems and have put processes in place to make the British Flag a safe and exceptional place to meet and enjoy other people's company.
- The site has tapped into a source of revenue that is available via customers later in the evening. This extra revenue is from a group of engineers and maintenance crew that maintain the wind farms and light house boats. All stay locally so there will be no calling of taxis later into the night so not cause a nuisance with car doors closing and engines running. These customers usually over the age of 27 through to 50 and stay in local guest accommodation (guest house/short term lets). Their work and rest times vary but mainly arrive to relax with us about 10pm-11pm most weekends.
- The Premises feel the extra hour will not put any burden on emergency services or create any problems with local residents. The tenant (Peter Vaughan) can be contacted and is happy to discuss anything in respect to the application.

#### 5.0 RELEVANT REPRESENTATIONS

#### 5.1 Interested Parties/Other Persons

- 5.2 The Police Reform and Social Responsibility Act 2011 (PRSR Act 2011) removed from the Licensing Act 2003 the specific reference for representations to be made by 'interested parties' and also removed the requirement that representations could only be accepted from persons living in the 'vicinity' of the premises concerned, or who had for example, a business in the 'vicinity' of the premises.
- 5.3 There was no guidance or definition of 'vicinity' within the Licensing Act 2003 which effectively had a limiting effect on those that could make relevant representations.
- The PRSR Act 2011 replaced the references to 'interested parties' and 'vicinity' and substituted that representations can be made and accepted by the Licensing Authority from 'other persons' which means that those persons do not necessarily have to live or run a

business for example in the proximity of the premises to be able to submit a valid and relevant representation.

- 5.5 The relevant extracts from the Section 182 Guidance that accompanies the Licensing Act 2003 advises the following in relation to 'other persons'. They are shown in italics for ease of reference.
  - 8.12 As well as responsible authorities, any other person can play a role in a number of licensing processes under the 2003 Act. This includes any individual, body or business entitled to make representations to licensing authorities in relation to applications for the grant, variation, minor variation or review of premises licences and club premises certificates, regardless of their geographic proximity to the premises.
- 5.6 Representations can be made either against or in support of an application. The relevant extracts from the Section 182 Guidance that accompanies the Licensing Act 2003 advises the following in relation to this point.
  - 9.3 Relevant representations can be made in opposition to, or in support of, an application and can be made by any individual, body or business that has grounds to do so.
- 5.7 12 letters of representations/objections have been received from residents in relation to this application.

#### 6.0 RESPONSIBLE AUTHORITIES

**6.1** One representation has been received from Essex Police with the following comments:

Essex Police decided that the application posed a risk to the residents of Harwich and formally objected to the variation on the 14th of July 2021. Essex Police made this objection under the Crime and Disorder and Public Nuisance licensing objectives.

Full details of the objection are included in Essex Police's supplementary bundle attached to this report.

- **6.2** The Council's Planning Authority has been consulted and no comments have been received.
- **6.3** The Council's Pollution and Environmental Control team has been consulted and no comments have been received.

#### 7.0 POLICY CONSIDERATIONS

The Licensing Authority's Statement of Licensing Policy expects applicants to demonstrate in their operating schedule that suitable and sufficient measures have been identified and will be implemented and maintained to prevent public nuisance relevant to the individual style and characteristics of their premises.

- 7.1 The relevant extracts from the Council's Statement of Licensing Policy in respect of Planning considerations (shown in italics) and also the 'Prevention of Public Nuisance' licensing objective are as follows:
- 1.20 When the Licensing Authority is considering any application, it will avoid duplication with other regulatory regimes, so far as possible, and does not intend to use the licensing regime to achieve outcomes that can be achieved by other legislation. In particular, its licensing functions will be discharged separately from the Authority's functions as the local planning authority. However, applications for premises licences for permanent commercial premises should normally be from businesses with planning consent for the property concerned. (Other permissions may be applicable to licensed premises and applicants are expected to ensure that such permissions are obtained where necessary.)

#### 5.0 PREVENTION OF PUBLIC NUISANCE

- 5.1 Licensed premises have a significant potential to impact adversely on communities through public nuisances that arise from their operation. The Licensing Authority wishes to maintain and protect the amenity of residents and other businesses from the consequence of the operation of licensed premises whilst recognising the valuable cultural, social and business importance that such premises provide.
- 5.2 The Licensing Authority intends to interpret "public nuisance" in its widest sense, and takes it to include such issues as noise, light, odour, litter and anti-social behaviour, where these matters impact on those living, working or otherwise engaged in normal activity in an area.
- 5.3 Applicants need to be clear that the Licensing Authority will normally apply stricter conditions, including controls on licensing hours, where licensed premises are in residential areas and where relevant representations have been received. Conversely, premises for which it can be demonstrated have effective measures planned to prevent public nuisance, may be suitable for 24-hour opening.
- 5.4 In the case of shops, stores and supermarkets selling alcohol, the Licensing Authority will normally permit the hours during which alcohol is sold to match the normal trading hours during which other sales take place, unless there are exceptional reasons relating to disturbance or disorder.
- 5.5 Applicants will be expected to demonstrate in their operating schedule that suitable and sufficient measures have been identified and will be implemented and maintained to prevent public nuisance, relevant to the individual style and characteristics of their premises and events.

#### 8.0 RELEVANT SECTION 182 GUIDANCE – PREVENTION OF PUBLIC NUISANCE

- 8.1 The following sections shown below in italics are taken from the Home Office Section 182 Guidance that accompanies the Licensing Act 2003 and are included for the assistance of the Licensing Sub Committee, the applicant, responsible authorities, residents and any other interested parties to this hearing. They do not however form the totality of the guidance in relation to this licensing objective which should also be considered in its entirety. These are:
- 2.18 The 2003 Act enables licensing authorities and responsible authorities, through representations, to consider what constitutes public nuisance and what is appropriate to prevent it in terms of conditions attached to specific premises licences and club premises certificates. It is therefore important that in considering the promotion of this licensing objective, licensing authorities and responsible authorities focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter.
- 2.19 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It is important to remember that the prevention of public nuisance could therefore include low-level nuisance, perhaps affecting a few people living locally, as well as major disturbance affecting the whole community. It may also include in appropriate circumstances the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises. Public nuisance may also arise as a result of the adverse effects of artificial light, dust, odour and insects or where its effect is prejudicial to health.

#### 9.0 RELEVANT SECTION 182 GUIDANCE- PREVENTION OF CRIME AND DISORDER

- 9.1 The following section shown below in italics is taken from the Home Office Section 182 Guidance that accompanies the Licensing Act 2003 and is included for the assistance of the Licensing Sub Committee, the applicant, responsible authorities, residents and any other interested parties to this hearing. They do not however form the totality of the guidance in relation to this licensing objective which should also be considered in its entirety. This is:
  - 2.1 Licensing Authorities should look to the police as the main source of advice on crime and disorder.

#### 10.0 RELEVANT SECTION 182 GUIDANCE -PLANNING AND BUILDING CONTROL

- 10.1 The following section shown below in italics is taken from the Home Office Section 182 Guidance that accompanies the Licensing Act 2003 and is included for the assistance of the Licensing Sub Committee, the applicant, responsible authorities, residents and any other interested parties to this hearing.
  - 13.56 The statement of licensing policy should indicate that planning permission, building control approval and licensing regimes will be properly separated to avoid duplication and inefficiency. The planning and licensing regimes involve consideration of different (albeit related) matters. Licensing committees are not bound by decisions made by a planning committee, and vice versa.
  - 13.57 There are circumstances when as a condition of planning permission, a terminal hour has been set for the use of premises for commercial purposes. Where these hours are different to the licensing hours, the applicant must observe the earlier closing time. Premises operating in breach of their planning permission would be liable to prosecution under planning law.





#### 1.0 Background

- 1.1 On the 24<sup>th</sup> of June 2021, Essex Police received notice of a full variation for the British Flag pub in Harwich. This application was made to increase the hours of the Sale of Alcohol by one hour.
- 1.2 On assessment of the application, Essex Police decided that the application posed a risk to the residents of Harwich and formally objected to the variation on the 14<sup>th</sup> of July 2021. Essex Police made this objection under the Crime and Disorder and Public Nuisance licensing objectives.
- 1.3 Essex Police's objection letter can be found in Appendix A.

#### 2.0 Facts of the Case

- 2.1 On the 15<sup>th</sup> of July, William Moody from Essex Police's Licensing Team contacted Darren Kelly, licensing team leader at Admiral Taverns to discuss terms that may be negotiated to ensure the licensing objectives are upheld and potentially negating the need for a licensing hearing.
- 2.2 Essex Police suggested that the increase in hours be reduced to a half an hour increase on Fridays and Saturdays, and that the following condition be added to the licence:

"last entry to the premises must end no later than one hour before the end of the licensed hours for that day"

The new times for the Sale of Alcohol have been agreed as the following with all other timings unchanged:

Sale of Alcohol on and off the premises - Fridays and Saturdays 10:00 - 01:30

- 2.3 Essex Police believe this will strike a balance between allowing the premises to expand its operation, while also safeguarding local residents against increases in crime, disorder or nuisance by removing the risk of the premises become a 'choke-point' and receive a high influx of patrons towards the end of the night.
- 2.4 On the 16<sup>th</sup> of July, Admiral Taverns confirmed that they agreed to this new amendment to the application.
- 2.5 Essex Police will suggest that the hearing be dispensed with under Section 9 of the Licensing Act 2003 (Hearings) Regulations 2005 in the eventuality that no other representations are made to the licensing authority. However, should other representations be made, Essex Police will keep their objection 'live' to enable them to attend the hearing and present this agreement to the subcommittee.
- 2.6 Should representations be made by other parties, Essex Police will agree to dispense with the hearing should these representations be withdrawn.
- 2.7 Essex Police will attend any hearing held in relation to this matter to present this information and answer any questions the sub-committee may have.

In the weeks since the reopening of pubs in May there have been a number of nights where the patrons of the pubs have been extremely noisy late into the night and blatantly ignoring the covid restrictions in place at the time. Due to the location of the door into the pub any noise echoes around the courtyard. I believe the pub has a new landlord who has taken over in the last few months. In the past loud music on the weekend, such as Karaoke nights, were always promptly stopped at a reasonable hour, such as 23:00 on a Saturday night.
	Since the current landlord has taken over the noise level often

increases after 22:30 or 23:30 at night and this has continued on until after 2.30am on occasions, we have contacted the police regarding the noise levels as it has a detrimental impact on us as residents. I've just been advised to direct my comments re. the above application, to yourself. I did try to find a way into a section of TDC's website, where I could write something there, but the link given at the bottom of the notice about it, which was posted to us a few days ago, was 'not recognised' and I'm eager to reach you before the end of today, which is the last opportunity for residents to submit any comments.

I live just over the road from the British Flag. My husband and I also work from this address, as do most of our neighbours in this side of the road. As our bedroom is on the same side of the road as the street, out first concern is that we need our sleep. I've not been able to find out if the extension of the licensing course includes Sunday night, but if it does, we would strongly object on these grounds, to live and recorded music going on till 1 am and probably more specially, people coming out of the pub at 2.30 on these nights.

There is another concern. In the past, when The Billy (further down the road but on the same side as the British Flag) stayed open till late, people coming out drunk because they'd been drinking for longer, regularly vandalised the cars in the street. I had a wing mirror smashed twice, my bonnet punched and my rear lights kicked in. My husband had damage done to his car, too. I am not comparing the British Flag to The Billy, but these past experiences and the very small police presence in Harwich, will make it clear to you why we feel wary about this application.

At the same time, the owners of the British Flag, like ourselves, need to make the best go of their business they can. We don't *know* what it will be like, which makes it hard to comment fairly on the outcome. If you plan to grant them this license, could we request a probationary period of say a month, so we can come back to you afterwards, with better informed opinions? Our worries may turn out to be completely unfounded. We're not against livemusic at all. It's only the potential volume of it, the timing of it and the proximity of it to our house.

It has just been brought to my notice that the new owner of the Public House "British Flag" at West Street, Harwich has applied for permission to extend its opening hours.

As the inn's open public area is almost adjacent to the rear of my residence and to the yard behind council/private houses from 58 West Street onwards I must strongly object to the approval of this request. Both private owners and residents of council houses on the yard are in agreement with my opinion.

What is also important for myself and my neighbours in Church Street is that we already have to cope with late night noise from the Stingray Public House which is across the street from us in Church Street. It needs to be said though that the owner of the Stingray does his utmost to keep the late night noise to a reasonable level.

I know that landlords are recently going through a rough time but cannot agree to the wishes for longer opening hours from the recent new owner of the British Flag. In the last couple of weeks we have already suffered excessive noise during the afternoon and long after midnight.

Please accept this email as objection to the above application to extend licensing hours at the British Flag.

I have been a home owner/resident in West Street Harwich (virtually opposite this public house) for a number of years and I feel strongly that I need to oppose this application, a view held by many local residents.

This public house is surrounded closely by residential dwellings. Many of these flats and houses house young families with children and elderly residents all of which will be affected by the noise and antisocial behaviour from the extended opening hours.

It is already a noisy and sometimes rowdy pub and on many occasions the police are called due to disturbance and fighting. This is particularly worrying for me as a single parent of a son with a developmental disorder. It is disturbing to listen to people brawling virtually outside the front of your home. On one occasion I had a couple arguing whilst sitting on my front door step swearing and shouting at each other. There is limited police presence in the town and I feel this will make the area a less safe place to live.

Old harwich appears to attract people driving around in the evenings carelessly and recklessly and I feel the extended opening times will courage this type of activity further into the early hours of the morning, a cause for concern for all residents.

Loud music and opening times extended into the early hours of the morning are likely to cause sleep disturbance to local residents. I work long hours in health care and need to sleep well in order to be able to manage the demands of my job. The inability to sleep is likely to have negative consequences for my concentration and ability to cope. I also have to consider my sons needs. He suffers with social anxiety disorder and ASD. This will likely cause him further stress and discomfort.

During my time of residence my car (parked outside my home) has been damaged on a number of occasions late at night (windscreen wiper broken off, scratches, wing mirror damage). I actually observed a group of young men pull the windscreen wiper from my car but felt unable to challenge them on my own whilst they were under the influence of alcohol. This has caused me emotional upset and financial hardship due to repairs and devalue, not to mention inconvenience as I need my car for work purposes.

There is already extremely limited parking in the area for local residents let alone further traffic that this may encourage.

I strongly feel that the extended licensing hours will have serious negative consequences for the local residents and fully oppose the application.
