**5. REPORT OF THE HEAD OF DEMOCRATIC SERVICES & ELECTIONS - A.1 -  
REVIEW OF THE YEARS 2019-2021 AND WORK PROGRAMME FOR 2021/22 FOR  
THE COMMUNITY LEADERSHIP OVERVIEW AND SCRUTINY COMMITTEE**

### **REPORT OF ASSISTANT DIRECTOR, PARTNERSHIPS**

#### **A.1 CRIME AND DISORDER / SAFER COMMUNITIES**

Report prepared by Leanne Thornton – Community Engagement Manager

#### **PURPOSE OF THE REPORT**

To address the issues of Anti-Social Behaviour and Domestic Abuse across the district, and to understand the various “Watch Groups” operating in the district.

#### **INVITEES**

Acting Chief Inspector Martin Richards (Tendring District Commander ) Essex Police

Essex Watch Liaison Officer – North LPA – Terry Fowles.

Acting Chief Inspector Richards will be undertaking a presentation to the Committee as well as answering questions on the recorded crime (including domestic abuse) and levels of Anti-Social Behaviour across the district.

Terry Fowles will be in attendance to answer questions about the various Watch Groups that function in the district including Neighbourhood Watch (NHW).

#### **BACKGROUND**

To help inform the emerging Police and Crime Plan, consider the implications of the plan for the district and to examine ways to support the community to address violence in a domestic setting and anti-social behaviour.

To understand the numbers of Police Officers and PCSO's over the last 5 years, what the current establishment of Officers is for Tendring district.

The extent to which Homewatch (or other Watch) groups exist across the District, the information flow to and from them and the support they require.

#### **DETAILED INFORMATION**

The Police & Crime Plan has been out for consultation since May 2021, at a recent Safer Essex Meeting the emerging themes were presented and discussed, these themes / emerging priorities were:

##### **Further Investment in Crime Prevention**

Our objective is to invest in activities and initiatives that prevent crime from happening in the first place, reducing overall crime and keeping our communities safe.

This objective includes the following:

- delivering more officers on top of the additional officers already delivered since 2016.
- Investing in neighbourhood policing to get crime down.
- Build on the success of our Community Safety Partnerships (CSPs) by encouraging increased targeting of hotspots and known offenders to tackle crime and antisocial behaviour (ASB).
- Invest further in Town Centre Teams following their success at getting crime down.
- Work with partners to improve community safety by investing in designing out crime.

### **Improving our Services to Support Victims of Crime**

Our objective is to recognise and prevent the harm caused to victims by the crime they experience, and the need to protect those who are most vulnerable to becoming victims.

This objective includes the following:

- Ensure victims are referred to support services tailored to their needs such as Restorative Justice.
- Collaborate with partners to share data and identify those most vulnerable to becoming victims and then delivered tailored, multi agency interventions to reduce the number of people becoming victims.
- Provide extra support and early intervention for people with additional needs or who are at increased risk.

### **Reducing Drug Driven Violence**

Through our Violence and Vulnerability Partnership we will:

- protect vulnerable people from gangs while we deal with the hardened criminals who prey on them.
- Take a public health approach to crime, focusing on keeping young people free from crime and intervening early to help steer them to a successful life course.
- Continue to fund projects across Essex focused on reducing serious violence.
- Fund activity to work with people vulnerable to being groomed into gangs, County Lines and drug driven violence.
- Fund activity to target gang members and help them step away from a criminal lifestyle.

### **Protecting Rural and Isolated Areas**

This objective includes the following:

- Make further investment in fighting rural crimes, such as hare coursing, wildlife crime, heritage crime, fuel theft, unauthorised incursions, and fly-tipping as well as the theft of major plant and equipment.

### **Improving Safety on Our Roads**

Together with the Safer Essex Roads Partnership this includes:

- Collaborate with councils and developers to ensure new and improved road networks are safe and have safety technology built in when they are developed.
- Invest in better speed cameras and upgraded Automatic Number Plate Recognition tracking.
- Co-locate Safer Essex Roads Partnership agencies to ensure a better service to the public.
- Work with rural communities and businesses to understand and improve rural road safety.

### **Encouraging Volunteers and Community Support**

- Continue to grow the Special Constabulary with the aim to have a Special Constable in every town and parish by growing the Community Special programme, and one in every major business through the Employer Supported Policing Scheme.
- Continue to support and collaborate with Neighbourhood Watch and look to develop other watch schemes such as Farm Watch and Pub Watch as well as supporting Crimestoppers.

### **Protecting and Supporting Vulnerable People and the Victims of Crime**

Our objective is to give a voice to those who need protection, support the vulnerable and reduce the number of people who becomes the victims of crime.

This objective includes the following:

- Have an even sharper focus on promoting awareness of domestic abuse, protecting, and supporting victims and survivors, and their dependents, investing further to strengthen the support available to them.
- Build on the work already started to further develop our understanding of the specific nature and impact of domestic abuse in rural communities and invest in initiatives to prevent and tackle it.
- Continue programme of investment in dedicated officers working in collaboration with other partners to support high volume repeat victims and tackle repeat perpetrators and break the cycle of domestic abuse.

### **Prevent Violence Against Women and Girls**

We will not tolerate male violence against women in any form, from sexual abuse and domestic abuse to verbal abuse and harassment in public places.

Our objective is to support a cultural change within society and provide strong, consistent, and vocal support for the safety of women and girls whether they report crimes against them or not.

### **Prevent Dog Theft**

Our objective is to do more to protect our pets and build confidence in how Essex Police handle dog thefts

### **Tackle Business Crime, Fraud and Cyber Crime**

Our objective is to work with businesses and individuals to tackle the surge in fraud and cyber-crime and to support Essex Police' Business Crime Strategy to help keep

businesses safe.

**Data on recorded crime (including domestic abuse), crime survey data and anti-social behaviour levels over the last five years – See Appendix A for detailed breakdown**

**Numbers of Police and PCSOs over the same period for the District of Tendring.**

Statistics are unavailable at this time, however, there are new officers stationed within Tendring and the recruitment drive for PCSO's is ongoing with interviews taking place at present.

**Details of measures specifically taken on the issue of domestic violence.**

- Tendring Police have a dedicated Domestic Abuse Team (DAIT) stationed at Clacton Police Station – All medium/High Risk DA's are reviewed/Investigated by the team.
- National Centre for Domestic Violence (NCDV) – this organisation take Referrals, however the Officer can only complete a referral on the victim's request.
- Next Chapter' is a Domestic Abuse Charity and take referrals young persons involved in Domestic Abuse, as well as providing Refuge services for adult women. Partnership working has been established with the Young Person's Officer in the North LPA linking in with local schools to help support youths with this pathway.
- National campaign, 'Ask ANI' - Domestic abuse codeword for pharmacies – People can attend a pharmacy showing the sign for "Ask ANI" and the staff within the pharmacy would know this person needs to discuss domestic abuse. Campaign is active in most Tendring Pharmacies.

**Details on local watch schemes including Neighbourhood Watch and Community Speed Watch.**

- Two priority road safety campaigns are currently being prepared by the Safer Essex Roads Partnership: \* Young Driver \* "Street Spirit", focused on Moped riders.
- Intelligence-led multi-agency operations focus on enforcing fatal 4 (speed, seatbelts, drink/drug driving/mobile phones)
- "Extra Eyes" campaign continues to review average 320 incidents supported with footage, prosecuting on average 140 road users.
- Tendring have various Community Speed Watch volunteers, based across Tendring – They work independently and alongside the local PCSO's.

**To examine ways to support community schemes to address anti-social behaviour.**

- The Children and Young Persons (CYP) officers are working with YMCA (a youth outreach program) and the EP/ECFRS Education team to provide workshops for young people on issues such as; gangs, knife crime, Child Criminal Exploitation (CCE), Child Sexual Exploitation (CSE) and Hate Crime. The work aims to build trust and confidence in police for young people so they feel more comfortable in reporting crime if they become a victim.
- Tendring Police have joined forces with The Community Safety Partnership (TDC) for their Street Action Days, this has enabled us to collate information and identify areas effected by ASB.

### **Reports/use of unlawful e-scooters and enforcement against those who use them.**

- E Scooter campaign - Op Solstice carried out across Tendring.
- On 14 June Essex Police commenced a Force wide E scooter campaign (Op Solstice) under the umbrella of Op Sunshade.  
The aim of the campaign was to provide a focussed period of enforcement and education activity, aimed at those riders choosing to use e- Scooters in an illegal or anti-social manner.  
Essex Police wrote to schools and asked them to brief parents to raise the awareness that private e scooters are illegal and only to be used on private land.
- The Roads Policing Unit led the campaign and provided guidance in relation to legislation but in essence unless the e scooter is part of the government scheme being run by Spin (grey and orange scooters) then it will be illegal, as there is no legal way of obtaining insurance and it can therefore be seized.
- Essex Police did not want to criminalise young children but if there are other offences going on (ASB, Drug running etc) action to be taken.

### **Tendring “Watch” – Information provided by Terry Fowles – Essex Watch Liaison Officer**

Listed below are the various “Watches” running in the Tendring District and numbers of members in each watch.


- Neighbourhood Watch (NHW) = 117 Co-Ordinators with approximately 3,000 members across the district



#### A.2 THE LAWFUL AND UNLAWFUL USE OF E-SCOOTERS AND THE EXTENT OF POLICING/ACTION AGAINST THOSE UNLAWFULLY USING THEM.

##### PURPOSE OF THE REPORT

The report provides information on the current position in relation to the use of e-scooters and policing action against those who use them unlawfully.

##### INVITEES

Tracey Vickers, Head of Sustainable Transport – Essex County Council  
Steve Pyer - Spin

##### BACKGROUND

Views differ on the potential benefits and problems presented by e-scooters. Some believe that they offer solutions to a wide range of transport policy goals (such as reducing pollution, congestion), while others believe that they are potentially dangerous and may undermine messaging about active travel and green transport.

While it is legal to buy or sell an e-scooter (classed as a battery-powered personal transport device), riding them on public roads, pavements or cycle lanes is against the law. Riders could face a £300 fine and six points on their licence if they use them on public roads or pavements. Riding e-scooters on private land is legal with the landowner's permission.

In the spring / summer of 2020, the Department for Transport (DfT) announced a proposal to trial the use of electric scooters in named pilot areas. Local authorities were encouraged to apply to become a pilot area, and Essex County Council (ECC) drafted proposals for Basildon, Braintree, Brentwood, Clacton, Chelmsford and Colchester. ECC then identified a preferred supplier – Spin – and submitted these proposals to the DfT.

ECC, in partnership with Spin, launched the trial in Clacton on 1 March 2021. Under the trial, e-scooters hired from Spin may be ridden on roads and cycle paths. There are currently 150 Spin e-scooters in Clacton, and the town is approaching 30,000 rides since the trial began. The trial will run until the end of October 2021, but consideration is being given to extending the trial until March 2022.

## DETAILED INFORMATION

### Legal Background

E-scooters are covered by the same laws and regulations that apply to all motor vehicles.<sup>14</sup> This means e-scooters need to meet the various requirements of the Road Traffic Act 1988 to use public roads lawfully (e.g. road tax, technical safety standards). The e-scooters currently on the market or available via hire schemes do not meet these requirements.

The 1988 Act (section 34) together with the Highways Act 1835 (section 72) also bans e-scooters (or as the law refers to them 'mechanically propelled vehicles') from pavements, cycle paths and public footpaths. This means that riders could face a £300 fine and six points on their licence if they use them on public roads or pavements.

Riding e-scooters on private land is legal only with the landowner's permission.

### E-scooter Trials

From 4 July 2020, local areas in England, Scotland and Wales have been able to undertake 12-month e-scooter rental trials, provided they meet DfT's requirements. The trials will be used to inform future government policy and possible legislative change. Trials have been launched in 32 trial areas across a mixture of towns, cities, local authorities and combined mayoral authority areas – including in Clacton on Sea.

During the trials:

- Rental e-scooters will be allowed on roads and cycle lanes, but will continue to be banned from pavements;
- E-scooters will be limited to a maximum speed of 15.5 mph (**in Clacton, the maximum speed is 12.5mph**);
- Riders should wear helmets, but they will not be mandatory;
- Privately-owned e-scooters will remain illegal; and
- Riders will need a full or provisional car, motorcycle or moped licence to use the devices, and they must be aged 16 or over.

The Electric Scooter Trials and Traffic Signs (Coronavirus) Regulations and General Directions 2020 (SI 2020/663) provide the legislative basis for the e-scooter trials. They define 'e-scooters' and amend road traffic regulations to exempt e-scooters being used in a trial from certain requirements of the Road Traffic Act 1988.

Regulation 2(3) of the 2020 Regulations defines an e-scooter as a vehicle that:

- is fitted with an electric motor with a maximum continuous power rating not exceeding 500 watts;
- is not fitted with pedals that are capable of propelling the vehicle;
- has two wheels, one front and one rear, aligned along the direction of travel;
- is designed to carry no more than one person;
- has a maximum weight, excluding the driver, not exceeding 55 kgs;
- has a maximum design speed not exceeding 15.5 miles per hour;
- has a means of directional control through the use of handlebars which are mechanically linked to the steered wheel;
- has a means of controlling the speed through hand controls; and

- has a power control that defaults to the 'off' position.

There are two requirements in primary legislation that will continue to apply to e-scooters in the trials:

- E-scooters in trials need to be covered by a motor vehicle insurance policy (**Spin has arranged insurance for authorised riders within the Clacton trial, and has a separate insurance policy for parked/unattended e-scooters**); and
- E-scooter users need to have a valid driving licence (provisional or full).

E-scooters which are not part of the trials will remain illegal on roads, cycle lanes and tracks, and on pavements.

### **Enforcement Issues**

#### The Lawful use on the public highway

Individuals that have a valid driving license can assess & use the legal e-scooters. The e-scooters must be ridden on a highway and must follow the highway code whilst using the vehicle.

#### The Unlawful use on a public highway

Any individual that is either riding a legal e-scooter unlawfully, such as riding without a valid driving license or disregarding the highway code, or is riding an unlicensed e-scooter will face positive action. Positive action will depend on the offence committed and the age of the rider– but could result in the e-scooter being seized and destroyed and the individual sent to magistrates court for contravention of Traffic Offences.

#### Misuse of hired e-scooters covered by the DfT's trial

E-scooters hired from Spin are equipped with GPS tracking devices, which allow the e-scooters to be 'geo-fenced'. This means that in certain areas of the town the e-scooters will go slower (e.g. the cycle lanes along the promenade), and in other areas they will not work at all (e.g. recreation grounds, and the multi-storey car park).

As all e-scooters are equipped with GPS tracking and are hired by the minute, misuse or illegal riding at a particular place and time can be tracked to a specific user.

As with any other type of vehicle, responsibility for addressing illegal riding rests with the police. Nevertheless, Spin take a proactive approach towards preventing misuse of their e-scooters. Spin's e-scooters are easily identifiable – due to their distinctive orange colour and large logo on the front – and the company encourages members of the public to report issues such as inconsiderate parking, riding on pavements, underage riders and more than one rider per e-scooter directly to them.

Users can have their accounts suspended for misuse, or be banned entirely depending on the severity of their infringement.

As well as direct enforcement against users who misuse their e-scooters, Spin also have preventative and educational strategies to help ensure e-scooters are used safely. All users must complete and pass in-app training – which features a quiz to ensure riders

understand where the e-scooters can and can't be used, and how to park them considerately – and regular in-app notifications provide reminders of the rules and laws.

In May, Spin ran a training event in the Leisure Centre car park – where 69 riders received in-person training on how to use the e-scooters safely, and each were given a free helmet on completion of the course.

Tendring Police currently have an operation underway to tackle the unlawful use of e-scooters, to include a media campaign, unfortunately the e-scooters are being seen as a toy by many and therefore perfectly acceptable, but only on private land, such as their own back gardens and absolutely not the public highway or pavements.

#### PART 1 – KEY INFORMATION

##### PURPOSE OF THE REPORT

To examine the informal partnerships that were harnessed during the Covid-19 pandemic lockdowns in 2020/21 and consider how those partnerships can inform future community partnerships going forward. Although the detail provided in this report was not specifically identified by Council for enquiry by the Committee, it was agreed with the Committee's Chairman to submit this information to it.

##### BACKGROUND

Partnership working, be it formal or informal, is consistent with the Council's commitment to put Community Leadership at the heart of everything we do through delivery of high quality, affordable services and working positively with others.

During the Covid-19 pandemic, a number of voluntary and community groups emerged in support of the most vulnerable and isolated residents across Tendring. The council responded by collecting and mapping out local voluntary and community group capability and making details of these groups and the services they offered widely available, to ensure those most in need of help could be promptly signposted to it. The groups in question provided a varied scale of assistance, ranging from help with accessing food and medicines, welfare checks and benefit help, mental health support and advice and telephone contact to help lessen feelings of isolation and boredom.

A large number of these groups were very localised and in many cases, consisted simply of supportive neighbours. Whilst these groups disbanded after the first and second waves of the pandemic had passed, we have established a clear process for capturing and communicating such information, to ensure residents are appropriately signposted. With the lifting of restrictions and the reopening of society, an opportunity now exists to reassess the support available through ongoing engagement with the voluntary and community sector in order to identify any changes to the data we hold, whether any gaps exist and if so, to address them where possible.

In addition to the above, there are a range of community groups that the council is currently working with as a result of the £220,000 successful funding bid to the Ministry of Housing, Communities and Local Government (MHCLG), received in January 2021. The MHCLG's Community Champions scheme aims to expand work to support those most at risk from Covid-19 and boost vaccine take up. In particular, it sought to provide additional support to particularly disadvantaged groups, such as disabled residents and the Black, Asian and minority ethnic (BAME) community, by developing new networks of trusted local champions where they did not already exist.

In April 2021, following a meeting of the Community Champions Grant Panel, it was decided that the MHCLG funding should be distributed, as set out in the table below.

For some organisations, the projects being funded were already in place but were at risk of ending or reducing. The Community Champions funding has allowed their work to be extended to increase either the number of days where support is offered, or the number of people they are able to reach. The grant funding has also provided the opportunity for some organisations to employ part time Community Champions, whose roles are specifically to work within the community and provide support and guidance. Where deprivation and isolation has been exacerbated by the pandemic in some areas, the Community Champions working within the district have created a link between the local community and the Council and local support services.

As a Council, we have been keen to ensure this scheme has forged stronger relationships within these local groups, opened additional lines of communication and provided a mechanism for accurate and relevant information to be shared. The Project Manager role has created a link between each funded organisation and has shared best practice, where relevant and beneficial. The Community Champions programme has allowed stakeholders to gain valuable information through review meetings held between the Project Manager and the funded organisations. It is unlikely that a forum of this kind would naturally have been created. The Community Champions funding has provided a platform for open and honest discussions and the sharing of such information.

Tendring District Council and the funded organisations are keen to retain and build upon the relationships and networks forged via the Community Champions project. Steps are being put in place to link Council Departments with organisations within the wider community. The Council will continue to work closely and in support of Community Voluntary Services Tendring to achieve a coherent and co-ordinated response to the needs of the local community.

Although the Community Champions project was primarily in response to the Covid-19 pandemic, the relationships that have been forged with local organisations have proven to be valuable to the Council. It has allowed a greater understanding of the diversity within our local community and thus ensure services remain accessible to our residents within the district.
