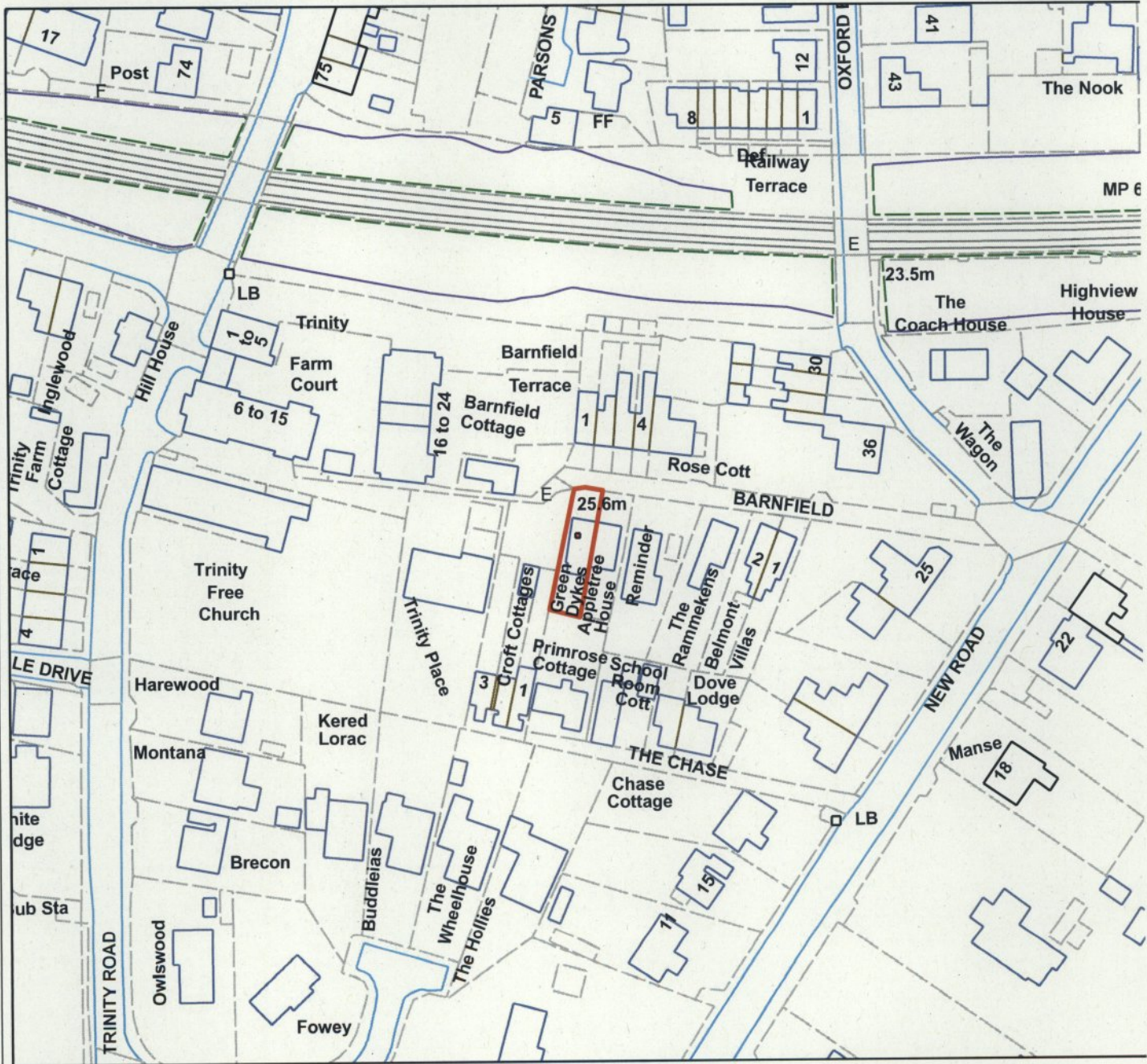

Notes
