5. Officer Appraisal

Site Description

The application site, St Marys Church, is situated in the village centre of Ardleigh, within the Ardleigh Conservation Area. The application site comprises of the listed building of St Marys Church and its churchyard. The church itself being mainly hidden from view by mature trees. A red brick wall and lych gate enclose the churchyard facing The Street and Colchester Road.

Description of Proposal

The application seeks advertisement consent for a replacement church noticeboard to be sited on the existing posts in the churchyard. The noticeboard will measure a maximum of 1.8 metres in height, 1.2 metres in width and will be aluminium powder coated in burgundy with white lettering. The noticeboard will be placed on the existing posts at 1 metre above ground level, making the total height of the noticeboard 2.8 metres. The maximum height of the letters or symbols on the noticeboard will be 20cms.

Appraisal

Paragraph 132 of the National Planning Policy Framework 2018 states that 'The quality and character of places can suffer when advertisements are poorly sited and designed' and 'Advertisements should be subject to control only in the interests of amenity and public safety, taking account of cumulative impacts'.

Amenity and Conservation Area

The proposed replacement sign/noticeboard is larger than the wooden sign it will replace and will occupy a prominent position behind the church wall. These type and styles of sign/noticeboard are now commonplace at entrances to churches giving details of the service. The colour of burgundy, although very different from the natural wood finish of the old noticeboard will be viewed above the red brick wall, with tones of red evident on the surrounding rooftops and lych gate roof. The sign is set back from the main road and will therefore be viewed from a distance. The sign/noticeboard is not considered to cause any significant harm to the conservation area and will not detract from the village feel and historic form that is apparent in the area of The Street and Colchester Road.

Public Safety

The replacement sign/noticeboard will not be illuminated, it will be sited within the churchyard and not on highways land. The churchyard is set back a considerable distance from the village crossroads junction and although the sign/noticeboard will be visible it will not obscure any highway signs or markings and will not therefore distract road users.

Other Considerations

No letters of representation have been received.

Conclusion

In the absence of material harm resulting from the proposal the application is recommended for approval.

7. Conditions

- All advertisement consents are subject to five standard conditions specified in Schedule 2 of the Town and Country Planning (Control of Advertisements) (England) Regulations 2007 which are as follows: -
 - 1. No advertisement is to be displayed without the permission of the owner of the site or any other person with an interest in the site entitled to grant permission.
 - 2. No advertisement shall be sited or displayed so as to
 - (a) endanger persons using any highway, railway, waterway, dock, harbour or aerodrome (civil or military);
 - (b) obscure, or hinder the ready interpretation of, any traffic sign, railway signal or aid to navigation by water or air; or
 - (c) hinder the operation of any device used for the purpose of security or surveillance or for measuring the speed of any vehicle.
 - 3. Any advertisement displayed, and any site used for the display of advertisements, shall be maintained in a condition that does not impair the visual amenity of the site.

- 4. Any structure or hoarding erected or used principally for the purpose of displaying advertisements shall be maintained in a condition that does not endanger the public.
- 5. Where an advertisement is required under these Regulations to be removed, the site shall be left in a condition that does not endanger the public or impair visual amenity.

Additionally all advertisement consents are for a fixed term of 5 years unless this period is varied on the formal decision notice.

The development hereby permitted shall be carried out in accordance with the following approved plans: Photo and sign details as shown on 'St Mary's Ardleigh Existing and proposed noticeboard'.
