## PURPOSE OF THE REPORT

To seek authority to proceed with the formal naming of the roads currently under construction on land off Harwich Road, Mistley, Manningtree, Essex.

## **EXECUTIVE SUMMARY**

A new development of 135 properties and 4 new roads has commenced on the site at the above location. The layout of this development is shown on the drawing attached as an Appendix to this report.
