## Status of the Local Plan

The 'development plan' for Tendring is the 2007 'adopted' Local Plan. Paragraph 213 of the NPPF (2018) allows local planning authorities to give due weight to adopted albeit outdated policies according to their degree of consistency with the policies in the NPPF. Paragraph 48 of the NPPF also allows weight to be given to policies in emerging plans according to their stage of preparation, the extent to which there are unresolved objections to relevant policies and the degree of consistency with national policy. As of 16th June 2017, the emerging Local Plan for Tendring is the Tendring District Local Plan 2013-2033 and Beyond Publication Draft.

Section 1 of the Local Plan (which sets out the strategy for growth across North Essex including Tendring, Colchester and Braintree) was examined in January and May 2018 and the Inspector's initial findings were published in June 2018. They raise concerns, very specifically, about the three 'Garden Communities' proposed in north Essex along the A120 designed to deliver longer-term sustainable growth in the latter half of the plan period and beyond 2033. Further work is required to address the Inspector's concerns and the North Essex Authorities are considering how best to proceed.

With more work required to demonstrate the soundness of the Local Plan, its policies cannot yet carry the full weight of adopted policy, however they can carry some weight in the determination of planning applications. The examination of Section 2 of the Local Plan will progress once matters in relation to Section 1 have been resolved. Where emerging policies are particularly relevant to a planning application and can be given some weight in line with the principles set out in paragraph

48 of the NPPF, they will be considered and, where appropriate, referred to in decision notices. In general terms however, more weight will be given to policies in the NPPF and the adopted Local Plan.

### 5. Officer Appraisal

### **Site Description**

The application site is on the east side of Fourth Avenue. The site comprises a two storey detached dwelling with private garden to the rear. The site is within the Frinton and Walton Conservation, 'The Avenues' Area of Special Character and the Development Boundary of Frinton On Sea.

#### Proposal

This application seeks planning permission for a single storey extension to the rear of the site, following the demolition of an existing extension. The proposal will fill a step in the rear elevation of the dwellinghouse, and extend a further 2.5m beyond the rearmost elevation. The proposal will extend 0.32m beyond the side elevation of the house. It will have a pitched roof with an eaves height of 2.46m and ridge height of 3.95m.

## **Appraisal**

The main considerations of this application are the visual impact, impact on the Conservation Area and Area of Special Character, impact on neighbours and private amenity space.

### Visual Impact and Impact on the Conservation Area and Area of Special Character

The proposed extension is sited to the rear of the host dwelling, so will be largely screened from view of the highway. Mature trees to the front of the site provide additional screening, so the extension will not be prominent in the street scene. The proposal is of a size and style which is in keeping with the character of the host dwelling and surrounding area and the use of matching materials will create a sense of cohesive development. The proposal will preserve the character of the conservation area and 'The Avenues' Area of Special Character.

#### Impact on Neighbours

The proposed extension is separated from the neighbouring property by 3.45m. The 45 degree sunlight/daylight test shows that there will be no significant impact on neighbouring daylight or outlook as a result of the proposal. As the proposal is only single storey, all windows are at ground floor level so will not impact neighbouring privacy.

#### **Private Amenity Space**

Policy HG9 of the Local Plan requires that new dwellings with 3 or more bedrooms be provided with at least 100 square meters of private amenity space. Following the erection of the proposal, 475 square metres will be retained in the back garden - which satisfies this policy.

#### Other Considerations

Frinton and Walton Town Council recommend approval.

One letter of representation has been received, raising concerns about the disruption caused by building works. Due to the nature and scale of the development, any disruption will not be for any significant length of time - so conditions regarding construction method are not appropriate.

#### Conclusion

In the absence of material harm as a result of the proposed development, this application is recommended for approval.
