Status of the Local Plan

The 'development plan' for Tendring is the 2007 'adopted' Local Plan. Paragraph 213 of the NPPF (2018) allows local planning authorities to give due weight to adopted albeit outdated policies according to their degree of consistency with the policies in the NPPF. Paragraph 48 of the NPPF also allows weight to be given to policies in emerging plans according to their stage of preparation, the extent to which there are unresolved objections to relevant policies and the degree of consistency with national policy. As of 16th June 2017, the emerging Local Plan for Tendring is the Tendring District Local Plan 2013-2033 and Beyond Publication Draft.

Section 1 of the Local Plan (which sets out the strategy for growth across North Essex including Tendring, Colchester and Braintree) was examined in January and May 2018 and the Inspector's initial findings were published in June 2018. They raise concerns, very specifically, about the three 'Garden Communities' proposed in north Essex along the A120 designed to deliver longer-term sustainable growth in the latter half of the plan period and beyond 2033. Further work is required to address the Inspector's concerns and the North Essex Authorities are considering how best to proceed.

With more work required to demonstrate the soundness of the Local Plan, its policies cannot yet carry the full weight of adopted policy, however they can carry some weight in the determination of planning applications. The examination of Section 2 of the Local Plan will progress once matters in relation to Section 1 have been resolved. Where emerging policies are particularly relevant to a planning application and can be given some weight in line with the principles set out in paragraph 48 of the NPPF, they will be considered and, where appropriate, referred to in decision notices. In general terms however, more weight will be given to policies in the NPPF and the adopted Local Plan.

5. Officer Appraisal

Proposal

This application seeks planning permission for the extension to the rear conservatory of a dwelling within the development boundary. Although the proposed conservatory might have been permitted development, because it will be joined to a previous rear and side extension it therefore exceeds the criteria of The Town and Country Planning (General Permitted Development) (England) Order 2015, Class A in relation to the original dwelling.

Design & Appearance

The proposed conservatory will be to the rear of the dwelling, and due to its single storey nature will not be prominent in the street scene. It is an appropriate size, scale and design for the host dwelling, and adequate private amenity space is retained to the rear.

Impact on Neighbours

The proposed conservatory will be 4m in depth, 1.65m deeper than the existing conservatory, and will have the same height and width. Due to the single storey nature of the proposal and the separation between the host dwelling and neighbouring property to the East, there will be no significant impact on neighbouring outlook, daylight or privacy. There is sufficient separation from neighbours to the South and West that they will not be affected by the proposal.

Other Considerations

No letters of representation have been received.

Conclusion

In the absence of material harm as a result of the proposed development, this application is recommended for approval.

7. Conditions

- 1 The development hereby permitted shall be begun before the expiration of three years from the date of this permission.

Reason - To comply with the requirements of Section 91 of the Town and Country Planning Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

- 2 The development hereby permitted shall be carried out in accordance with the following approved plans: Site Plan scale 1:200, Proposed Floor Plan and Rear Elevation scale 1:100, and Proposed Side Elevations scale 1:100.

Reason - For the avoidance of doubt and in the interests of proper planning.
