A.1 PROPOSED NAMING AND NUMBERING

PART 1 – KEY INFORMATION

PURPOSE OF THE REPORT

To seek authority to proceed with the formal naming of the road currently under construction on land at Michaelstowe Farm, Ramsey Road, Ramsey, Essex.

EXECUTIVE SUMMARY

A new development of 14 (fourteen) properties and 1 (one) new road has commenced on the site at the above location. The layout of this development and the proposed postal addresses is shown on the drawing attached as an Appendix to this report.

RECOMMENDATION(S)

(a) That the new road shown on the site plan attached as an Appendix to this report is named “Michaelstowe Lane”.

Reason:- After the nearby farm, who’s fields are being used to develop on. The farmer is now deceased.

(b) That all interested parties be advised of the name allocated to the new road.
