Status of the Local Plan

The 'development plan' for Tendring is the 2007 'adopted' Local Plan. Paragraph 213 of the NPPF (2018) allows local planning authorities to give due weight to adopted albeit outdated policies according to their degree of consistency with the policies in the NPPF. Paragraph 48 of the NPPF

also allows weight to be given to policies in emerging plans according to their stage of preparation, the extent to which there are unresolved objections to relevant policies and the degree of consistency with national policy. As of 16th June 2017, the emerging Local Plan for Tendring is the Tendring District Local Plan 2013-2033 and Beyond Publication Draft.

Section 1 of the Local Plan (which sets out the strategy for growth across North Essex including Tendring, Colchester and Braintree) was examined in January and May 2018 and the Inspector's initial findings were published in June 2018. They raise concerns, very specifically, about the three 'Garden Communities' proposed in north Essex along the A120 designed to deliver longer-term sustainable growth in the latter half of the plan period and beyond 2033. Further work is required to address the Inspector's concerns and the North Essex Authorities are considering how best to proceed.

With more work required to demonstrate the soundness of the Local Plan, its policies cannot yet carry the full weight of adopted policy, however they can carry some weight in the determination of planning applications. The examination of Section 2 of the Local Plan will progress once matters in relation to Section 1 have been resolved. Where emerging policies are particularly relevant to a planning application and can be given some weight in line with the principles set out in paragraph 48 of the NPPF, they will be considered and, where appropriate, referred to in decision notices. In general terms however, more weight will be given to policies in the NPPF and the adopted Local Plan.

5. Officer Appraisal

Proposal

This application seeks planning permission for a single storey side and rear extension, and a front porch to a single storey detached dwelling within the Development Boundary of Clacton on Sea.

Design and Appearance

The side and rear extension will replace conservatories to the rear and an attached shed to the side of the property. The side element of this extension will be the most publically visible, and represents a visual improvement over the existing structure - particularly as it increases separation between the building and the side boundary. The use of matching materials will ensure the extension appears in keeping with the main house, and the flat roof will maintain a sense of subservience. The rear element of the extension increases the bulk to the rear of the property - but as it will be largely screened and is only single storey with a flat roof, any impact will not be significant. Adequate private amenity space is retained to the rear of the property.

The proposed front porch will also be a visual improvement over the existing porch, which has significantly different materials to the rest of the dwelling, as the proposed materials will match across the front elevation of the dwelling and there will be a greater sense of cohesion.

Impact on Neighbours

Due to the separation between the proposal and each neighbouring dwelling, and the single storey nature of the proposals, there will be no significant impact on neighbouring daylight or outlook. The proposed side facing windows are at ground floor level, and there is an existing tall fence at this boundary so neighbouring privacy will not be impacted.

Other Considerations

No letters of representation have been received.

Conclusion

In the absence of material harm as a result of the proposed development, this application is recommended for approval.
