PART 1 – KEY INFORMATION

PURPOSE OF THE REPORT

To seek authority to proceed with the formal naming of the road currently under construction on land at Lawford House, Bromley Road, Lawford, Essex.

EXECUTIVE SUMMARY

A new development of 8 properties and 1 new road has commenced on the site at the above location. The layout of this development and the proposed postal addresses are shown on the drawing attached as an Appendix to this report.

RECOMMENDATION(S)

(a) That the new road shown on the site plan attached as an Appendix to this report is named "Cranswick Place".

Reason: - After the late Mr Jesse Cranswick, the first head teacher at the local Senior School in 1937, prior to that the headmaster at the Mistley Norman School. Jesse was also Vice President, Chairman, and Vice Chairman of the local British Legion in Manningtree. He had much involvement with the Parish Council and surrounding villages. Jesse was also awarded the Military Cross in 1917 for his bravery whilst serving in the Bedfordshire Regiment on the Western front.

(b) That all interested parties be advised of the name allocated to the new road.
