Status of the Local Plan

The 'development plan' for Tendring is the 2007 'adopted' Local Plan. Paragraph 213 of the NPPF (2019) allows local planning authorities to give due weight to adopted albeit outdated policies according to their degree of consistency with the policies in the NPPF. Paragraph 48 of the NPPF also allows weight to be given to policies in emerging plans according to their stage of preparation, the extent to which there are unresolved objections to relevant policies and the degree of consistency with national policy. As of 16th June 2017, the emerging Local Plan for Tendring is the Tendring District Local Plan 2013-2033 and Beyond Publication Draft.

Section 1 of the Local Plan (which sets out the strategy for growth across North Essex including Tendring, Colchester and Braintree) was examined in January and May 2018, with further hearing sessions in January 2020. The Inspector issued his findings in respect of the legal compliance and soundness of the Section 1 Plan in May 2020. He confirmed that the plan was legally compliant and that the housing and employment targets for each of the North Essex Authorities, including Tendring, were sound. However, he has recommended that for the plan to proceed to adoption, modifications will be required – including the removal of two of the three Garden Communities 'Garden Communities' proposed along the A120 (to the West of Braintree and on the Colchester/Braintree Border) that were designed to deliver longer-term sustainable growth in the latter half of the plan period and beyond 2033.

The three North Essex Authorities are currently considering the Inspector's advice and the implications of such modifications with a view to agreeing a way forward for the Local Plan. With the Local Plan requiring modifications which, in due course, will be the subject of consultation on their own right, its policies cannot yet carry the full weight of adopted policy, however they can carry some weight in the determination of planning applications – increasing with each stage of the plan-making process.

The examination of Section 2 of the Local Plan (which contains more specific policies and proposals for Tendring) will progress once modifications to the Section 1 have been consulted upon and agreed by the Inspector. Where emerging policies are particularly relevant to a planning application and can be given some weight in line with the principles set out in paragraph 48 of the NPPF, they will be considered and, where appropriate, referred to in decision notices. In general terms however, more weight will be given to policies in the NPPF and the adopted Local Plan.

5. Officer Appraisal (including Site Description and Proposal)

Proposal

This application seeks permission for the erection of a single storey side extension.

Application Site

The site is located to the west of Third Avenue, Clacton on Sea. The site serves a semi-detached two storey dwelling, the exterior walls are constructed from painted render and the roof pitched and tiled. The surrounding streetscene is comprised from dwellings of a similar design and appearance. There is an open green recreation area opposite to the application site.

Assessment

Design and Appearance

One of the core planning principles of The National Planning Policy Framework (NPPF) as stated at paragraph 130 is to always seek to secure high quality design. Saved Policies QL9, QL10 and QL11 aim to ensure that all new development makes a positive contribution to the quality of the local environment, relates well to its site and surroundings particularly in relation to its form and design and does not have a materially damaging impact on the amenities of occupiers of nearby properties. Emerging Policy SP1 reflects these considerations.

The proposed side extension will measure 4.7 metres wide at the rear and 4 metres deep at the side elevation where it then connects to the existing garage, it will have a maximum height of 3.7 metres. The proposed side extension is considered to be of a size and scale in keeping with the existing dwelling and surrounding area. The application site can accommodate for a proposal of this size and scale whilst retaining adequate private amenity space.

The proposed extension will be located to the north of the site at the rear, it will be partly visible to the streetscene although largely shielded by the existing garage. It will be constructed from materials to match those of the existing dwelling, the exterior walls will be of painted render and the roof pitched and tiled with a flat roof design towards the rear. Two velux roof lights and 1 flat roof dome light are also proposed. The windows and doors will be of a light oak effect UPVC to match those of the existing. The proposal is considered to be of a design in keeping with the existing dwelling and surrounding area and will therefore not have any adverse effect on the visual amenities of the area.

Impact to Neighbouring Amenities

The NPPF, Paragraph 17, states that planning should always seek to secure a good standard of amenity for all existing and future occupants of land and buildings. In addition, Policy QL11 of the saved plan states that amongst criteria 'development will only be permitted if the development will not have a materially damaging impact on the privacy, daylight or other amenities of occupiers of nearby properties'. These sentiments are carried forward in Policy SPL3 of the Tendring District Local Plan 2013-2033 and Beyond Publication Draft (June 2017).

The proposal is of a single storey nature and therefore does not pose any significant threat of overlooking onto neighbouring properties.

The proposal is to be built away from the shared neighbouring boundary line south of the site and so does not have any significant impact to the loss of daylight nor privacy not thought to cause any other harm to the amenities of this neighbouring dwelling.

The proposal is to be built 0.8 metres from the neighbouring boundary line north of the site. There are no windows on the neighbouring dwelling along this shared boundary line. The proposed extension is therefore not considered to have any significant impact to the loss of light to this neighbouring dwelling. No windows are proposed along this elevation on the proposed extension however there is one new door proposed to allow access into the garage, the proposal is not considered to have any significant impact on the loss of privacy to the neighbouring dwelling to the north.

The proposal is set away from the neighbouring dwellings to the rear of the site and is not thought to have any significant impact on the loss of privacy, daylight or cause harm to any other amenities of the adjacent neighbours.

Highway issues

The proposal neither generates an additional need for parking nor decreases the existing parking provision at the site.

Other Considerations

Clacton is non parished and therefore no comments will be required.

No other letters of representation have been received.

Conclusion

It is considered that the proposed development is consistent with the National and Local Plan Policies identified above. In the absence of material harm resulting from the proposal the application is recommended for approval.

6. Recommendation

Approval - Full

7. Conditions / Reasons for Refusal

- 1 The development hereby permitted shall be begun before the expiration of three years from the date of this permission.

Reason - To comply with the requirements of Section 91 of the Town and Country Planning Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

- 2 The development hereby permitted shall be carried out in accordance with the following approved plan; Drawing No. 01.

Reason - For the avoidance of doubt and in the interests of proper planning.
