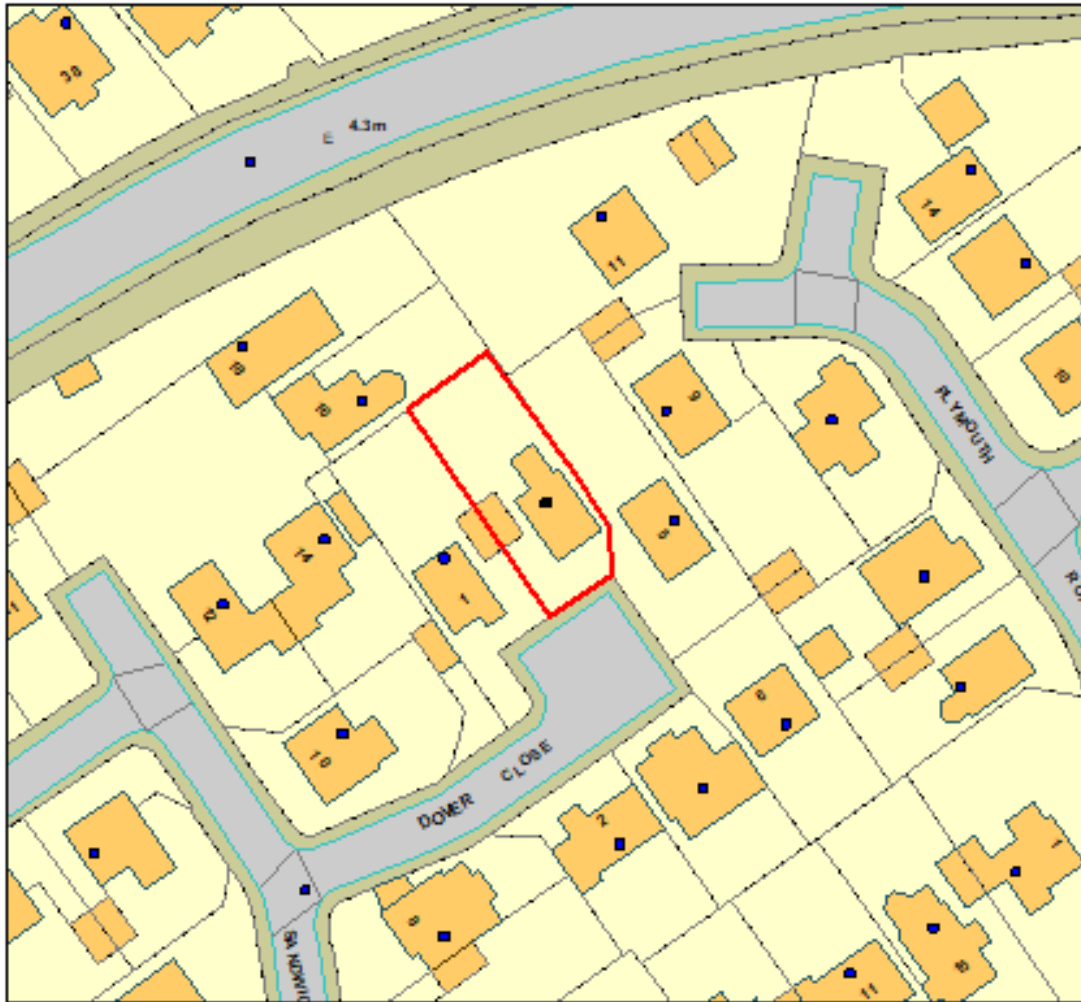

Notes
