## Delegated Power Ref: Cabinet Minute No. 50 meeting held on 11/10/2019 Request for Consent to gain Exemption from Call-in Procedure

Councillor Paul Honeywood proposed to make the following executive decision:-

To consider whether to accept the transfer of Plot 4, 8 Brunswick Gardens, Mistley, to the Council as an Affordable Housing Dwelling and to agree to acquiring a shareholding in Harwich Road Management Limited.

Any delay likely to be caused by the call-in process would seriously prejudice the Council's or the public's interest for the following reasons:-

The decision is required urgently because, the Council had been put on notice that the delay to be caused by the call-in process would seriously prejudice the public interests. The developer is unable to dispose of another other bungalow on the development site, which was due to be purchased by an elderly couple, who have nowhere else to live and will need to be put up in temporary accommodation– given the COVID risks currently this is unacceptable and would be putting them at great risk.

The developer is restricted by the terms of the Section 106 Agreement in that they cannot dispose of properties until the gifted unit is transferred to the Council, completion was due for next Friday 4<sup>th</sup>December and they would like to complete on 27<sup>th</sup> November 2020.

This letter therefore formally records our telephone conversation and email correspondence on 26<sup>th</sup> November, proposing that the decision should be exempt from the call-in procedure by virtue of Rule 18(i) of the Overview and Scrutiny
