Concurrence with Officer Decision: Procurement of the Cliff Stabilisation Project between Cliff Road and York Road, Holland on Sea.

I write to seek your concurrence in respect of an officer decision to award the construction of the Cliff Stabilisation Project between Cliff Road and York Road to Breheny Civil Engineering Limited of Flordon Road, Creeting St Mary, Needham Market, Ipswich Suffolk, IP6 8NH.

The procurement documents have been produced in line with Option A (fixed priced) of the NEC Standard form of contract. Tenders have been invited, received and assessed.

The lowest tender returned was submitted by Breheny Civil Engineering at £1,930,212.92 although including proposed revised working methods. The second-lowest tender was received was at £2,978,906,70. Other tenders received exceeded the estimated costs.

Breheny Civil Engineering Limited have been identified as the best tenderer after a full procurement and evaluation process.

Full details are set out in Cabinet report dated April 2021.

Accordingly I propose to: Award the construction of the Cliff Stabilisation Project between Cliff Road and York Road, Holland on Sea, to Breheny Civil Engineering Limited.
