PART 1 - KEY INFORMATION

PURPOSE OF THE REPORT

To seek approval for the granting of a new lease over land and property known as Batemans Tower, Brightlingsea shown edged red on the plan at Appendix A.

EXECUTIVE SUMMARY

The current tenants have rented the property for over 40 years and are holding over on a 21 year lease that expired on the 31 March 2021. The tenants have requested that they are granted a new lease for a further 15 years.

It is proposed to grant a new 15 year lease in accordance with the Heads of Terms set out in the concurrent confidential report.

RECOMMENDATIONS

That the Portfolio Holder approves the principle of the granting of a new 15 year Lease over the land and property known as Batemans Tower, Brightlingsea.
