PART 1 – KEY INFORMATION

PURPOSE OF THE REPORT

To seek authority to proceed with the formal naming of the roads currently under construction on Land at Turpins Farm, off Elmtree Avenue, Kirby-le-Soken, Essex

EXECUTIVE SUMMARY

A new development of 210 properties and 8 new roads has commenced on the site at the above location. The layout of this development is shown on the drawing attached as an Appendix to this report.

RECOMMENDATION(S)

(a) That the new roads shown on the site plan attached as an Appendix to this report are named: - “Rowan Way”, “Aspen Close”, “Cherry Avenue”, “Hazel Avenue”, “Jasmine Close”, “Blackthorn Avenue”, “Bracken Way” and “Sapphire Way”..

(b)

Reason: - These are all Tree Species, some of which found locally and some that will remain within the development site. In view of this, it is felt that the suggested names would follow a theme very much in keeping with the area, in particular the site for development.

That all interested parties be advised of the name allocated to the new roads.

proposed names, the person proposing the name may appeal against the objection to a Petty Sessional Court, under Section 17 of the Public Health Act 1925.
