I acknowledge receipt of your fare tariff request submitted on 20 June 2022.

I'm sure you are aware, the Licensing Authority have also received a different fare increase request from Tendring Taximeter Forum.

I have a couple of emails from you due to an error you made on the first request.

Please can you confirm you are requesting the following:

Rate 1

£3.40 ring on and for the first 235 yards.

£0.30 for each additional 235 yards.

Rate 2 would be time and a half as per the tariff now.

Your request also includes a change in the yards from the current yardage.

Once I have received confirmation of the above, I will be arranging a Licensing Committee to discuss these requests further in line with the taxi process we have to carry out.

With regret I have decided to stop Taxi Driving for the time being due to rising fuel costs & reduced demand due to rising cost of living.

My hourly wage based on hours worked for the past 1 month equates to £7.50, £2 below national minimum wage,,

Most of the local taxi drivers are on the same position. Most of the taxi drivers I had a talks in a last few days are ready to resign in a next couple of months. We providing the vital service for the local community (school transport, hospital transport and social care transport) , but with a current fuel prices and fares I am afraid we will be unable to to it.
