Following the decision previously agreed by yourself and Councillor Guglielmi, please find attached a further concurrence with clarification regarding spend on two of the projects approved for year 1 of the UK Shared Prosperity Fund (UKSPF), for your agreement.

Please note that there are no changes to the projects benefitting from the funding, or to the amounts each project is receiving. The concurrence is to capture a change to the aspect of the Jaywick Managed Workspace project which UKSPF will be supporting, and to clarify that the repairs to the seafront ramp proposed in the previous decision constitute revenue spend, not capital spend.
