Status of the Local Plan

Planning law requires that decisions on applications must be taken in accordance with the development plan unless there are material considerations that indicate otherwise (Section 70(2) of the 1990 Town and Country Planning Act and Section 38(6) of the Planning and Compulsory Purchase Act 2004). This is set out in Paragraph 2 of the National Planning Policy Framework (the Framework). The 'development plan' for Tendring comprises, in part, Sections 1 and 2 of the Tendring District Council 2013-33 and Beyond Local Plan (adopted January 2021 and January 2022, respectively), together with any neighbourhood plans that have been brought into force.

5. Officer Appraisal (including Site Description and Proposal)

Proposal

This application seeks permission for the erection of a single storey rear extension following demolition of existing conservatory.

Assessment

Design and Appearance

The proposed extension is located to the rear of the dwelling and is of a single storey nature, it will therefore be shielded from the public views of the streetscene by the existing dwelling.

The application site can accommodate for the proposal whilst retaining adequate private amenity space. The proposed extension is deemed to be of an appropriate size and scale in relation to the host dwelling and its locality.

The proposed extension will be finished in painted render to match with that of the existing dwelling, with a flat roof design incorporating a roof lantern. The proposal is deemed to be of an acceptable design and appearance with no significant harmful impacts on visual amenities.

Impact to neighbouring dwellings

The proposal is of a single storey nature and therefore poses no significant risk of overlooking or loss of privacy to the neighbouring dwellings.

Due to the single-storey flat-roofed nature of the proposal it is not considered to have any significant impact on the loss of light to the attached neighbouring dwelling. It is located an adequate enough distance from other neighbouring dwellings as to have no impact on the loss of light.

Highway issues

The Proposal neither generates an additional need for parking, nor decreases the existing parking provisions at the site.

Other Considerations

Clacton is non-parished and therefore no comments are required.

No other letters of representation have been received.

Conclusion

It is considered that the proposed development is consistent with the National and Local Plan Policies identified above. In the absence of material harm resulting from the proposal the application is recommended for approval.

NOTE/S FOR CONDITION:

The development needs to commence within the timeframe provided. Failure to comply with this condition will result in the consent becoming lapsed and unable to be carried out. If commencement takes place after the time lapses this may result in unlawful works at risk of both Enforcement Action and Criminal proceedings.
