Status of the Local Plan

Planning law requires that decisions on applications must be taken in accordance with the development plan unless there are material considerations that indicate otherwise (Section 70(2) of the 1990 Town and Country Planning Act and Section 38(6) of the Planning and Compulsory Purchase Act 2004). This is set out in Paragraph 2 of the National Planning Policy Framework (the Framework). The 'development plan' for Tendring comprises, in part, Sections 1 and 2 of the Tendring District Council 2013-33 and Beyond Local Plan (adopted January 2021 and January 2022, respectively), together with any neighbourhood plans that have been brought into force.

5. Officer Appraisal (including Site Description and Proposal)

Proposal

This application seeks permission for the erection of a single storey rear extension to form living room (following demolition of defective existing extension).

Assessment

Design and Appearance

The application site is able to accommodate for the proposed extension whilst retaining adequate private amenity space. It is therefore deemed to be of an acceptable size and scale.

The extension is of a single storey nature with flat roof design. The majority of the exterior walls will be finished in render, with the wall facing No. 104 finished in brickwork. The proposal is considered to be of an in keeping design and appearance to that of the host dwelling and its locality. Due to its siting at the rear of the dwelling it will not be visible to the public views of the streetscene. It therefore has no significant harmful impact on the visual amenities of the area.

Impact on Neighbouring Amenities

The proposal is of a single storey nature and therefore poses no significant risk of overlooking or loss of privacy to the adjacent dwellings.

The flat roof nature and minor height of the proposal means it will not have any significant impact on the loss of light to the neighbouring dwellings. Any loss of light would first be intercepted by the existing fence line and thus significantly reduced. Furthermore, the adjacent dwelling towards the north of the site has a conservatory to the rear, providing adequate glazing to the rear of the property and adequate light source is retained. The proposal is located a significant enough distance from the neighbouring dwelling south of the site (No. 100) as to have no impact on the loss of light.

Other considerations

The proposal does not alter the existing parking provisions at the site, nor does it cause an additional need for parking. The Local Planning Authority therefore deem the application is acceptable in terms of highway safety.

Clacton is non-parished and so no comments are required.

No other letters of representation have been received.

Conclusion

The proposal is consistent with the above mentioned National and Local Policies. In the absence of material harm the proposal is recommended for approval.

1 COMPLIANCE REQUIRED: COMMENCEMENT TIME LIMIT

CONDITION: The development hereby permitted shall be begun not later the expiration of three years from the date of this permission.

REASON: To comply with the requirements of Section 91 of the Town and Country Planning Act 1990 as amended by Section 51 of the Planning and Compulsory Purchase Act 2004.

NOTE/S FOR CONDITION:

The development needs to commence within the timeframe provided. Failure to comply with this condition will result in the permission becoming lapsed and unable to be carried out. If commencement takes place after the time lapses this may result in unlawful works at risk Enforcement Action proceedings.
