# A. RELEASE OF SECTION 106 FUNDS FOR IMPROVEMENTS TO TOKELY ROAD PLAY AREA

#### PART 1 - KEY INFORMATION

# **PURPOSE OF THE REPORT**

To seek approval to release £142486.22 Section 106 for the improvements of Tokely Road Play Area, Frating.

#### **EXECUTIVE SUMMARY**

- As a result of an acknowledged deficit in play provision in the area, planning applications relating to a housing development in Frating secured unilateral undertakings for payments in respect of open space and play totalling £142486.22
- The S106 agreement requires the contribution to be used towards the provision and/or replacement and/or maintenance of play equipment at the play area located on Tokely Road opposite the site.
- The new development adjacent to the existing play area, only provided open space, due to the location of the existing play area and off site contribution was secured via a \$106 agreement.

# **RECOMMENDATION(S)**

#### It is recommended that:

a) That the Portfolio Holder approves

The release of £142486.22 to enable Tendring District Council to make improvements to the play area at Tokely Road, Frating.

# REASON(S) FOR THE RECOMMENDATION(S)

To enable Tendring Council to provide improvements and new play equipment on the existing play area at Tokely Road.

The Council could choose not to release the money. As this can only be allocated for the improvements to play facilities as this site. The money would need to be returned to the developer.

# FINANCE AND OTHER RESOURCE IMPLICATIONS

Planning application 18/00194/FUL secured unilateral undertakings for payments in respect of open space and play totalling £142486.22.

The section 106 agreement all require the Play Equipment Contribution to be used towards the provision of equipment and / or the improvement of play facilities at the area of open in Tokely Road, Frating. It is not possible to spend the money anywhere else.

The only alternative to using the contribution towards the improvement of the play area in Tokely Road, Frating is to return the money to the developers.

The proposal in this report if agreed, will ensure the provision of high quality play facilities available to local children including the most vulnerable younger members of the Tendring community, with no impact on existing budgets.

#### PART 3 - SUPPORTING INFORMATION

#### **BACKGROUND**

Following the recent increase in development in Frating the Parish Council have identified a need to provide new play facilities to cope with the additional residents that now live in the Parish, as Tendring District Council own the play area in Frating the Parish Council have approached us directly.

Play areas act as focal points for the community, providing a meeting area for children and parents alike. In an age when younger generations can appear more concerned with the latest technology than social interaction, the importance of playgrounds cannot be underestimated in bringing people together. They offer a place for children to play and forge new friendships, while ensuring they remain healthy and active.

There is currently a deficit of play facilities Frating. Tokely Road provides the only open space and play facilities that are within walking distance for the residents.

Increasing the current range of play equipment to include for all children can only increase opportunities for the whole community and to broaden children's knowledge and experience as well as provide significant social benefit associated with the community gathering for a common purpose.
