Status of the Local Plan

Planning law requires that decisions on applications must be taken in accordance with the development plan unless there are material considerations that indicate otherwise (Section 70(2) of the 1990 Town and Country Planning Act and Section 38(6) of the Planning and Compulsory Purchase Act 2004). This is set out in Paragraph 2 of the National Planning Policy Framework (the Framework). The 'development plan' for Tendring comprises, in part, Sections 1 and 2 of the Tendring District Council 2013-33 and Beyond Local Plan (adopted January 2021 and January 2022, respectively), supported by our suite of evidence base core documents (<https://www.tendringdc.uk/content/evidence-base>) together with any neighbourhood plans that have been brought into force.

Neighbourhood Plans

A neighbourhood plan introduced by the Localism Act that can be prepared by the local community and gives communities the power to develop a shared vision for their area. Neighbourhood plans can shape, direct and help to deliver sustainable development, by influencing local planning decisions as part of the statutory development plan to promote development and uphold the strategic policies as part of the Development Plan alongside the Local Plan. 5. Officer Appraisal (including Site Description and Proposal)

Application Site

The application site is 32 St Pauls Road Clacton-On-Sea, a south-west facing brick built two storey detached dwelling. The site is separated from the highway by a low brick wall behind which is a mixture of hard and soft landscaping. The rear garden is enclosed with fencing and mature vegetation, which runs along the shared boundaries. A driveway granting access to 30a St Pauls Road runs along the site southern boundary.

Proposal

This application seeks planning permission for the erection of a single storey rear extension following the removal of the existing conservatory.

Assessment

The key considerations of this application will be Design and Appearance, Impact upon the Neighbours and Other Considerations.

Design and Appearance

As a result of the proposal being located to the rear of the site and screened by the bulk of the main dwelling, the proposed development will have no harmful impact upon the streetscene. The rear garden is considered to be of a sufficient size to be able to accommodate the proposal and still retain adequate private amenity space.

The proposal is a single storey rear extension with a gable roof design. The extension will be finished in render with an aluminium bi-fold door. The use of these finishes will help tie the development in with the host dwelling, significantly reducing the potential harm the proposal may have upon the visual amenities of the area.

Impact to Neighbours

The site abuts 34 St Pauls Road to north and 30 & 30a to the south. Due to its single storey nature, lack of openings on the side elevation, screening provided by the existing boundary treatment and the closest neighbouring property being approximately 8 metres from the rear extension, the

proposal is considered to pose no significant impact to the neighbouring properties privacy, light or outlook to warrant refusal.

Other considerations

Clacton-on-Sea is non-parished.

No letters of representation have been received.

Conclusion

The proposed development is consistent with the above mentioned national and local planning policies. In the absence of material harm, the proposal is recommended for approval.

1 COMPLIANCE REQUIRED: COMMENCEMENT TIME LIMIT

CONDITION: The development hereby permitted shall be begun not later the expiration of three years from the date of this permission.

REASON: To comply with the requirements of Section 91 of the Town and Country Planning Act 1990 as amended by Section 51 of the Planning and Compulsory Purchase Act 2004.

NOTE/S FOR CONDITION:

The development needs to commence within the timeframe provided. Failure to comply with this condition will result in the permission becoming lapsed and unable to be carried out. If commencement takes place after the time lapses this may result in unlawful works at risk Enforcement Action proceedings. You should only commence works when all other conditions requiring agreement prior to commencement have been complied with.

CONDITION: The development hereby permitted shall be carried out in accordance with the drawings/documents listed below and/or such other drawings/documents as may be approved by the Local Planning Authority in writing pursuant to other conditions of this permission or such drawings/documents as may subsequently be approved in writing by the Local Planning Authority as a non-material amendment following an application in that regard (except for Listed Building Consents). REASON: For the avoidance of doubt and in the interests of proper phased planning of the development.

NOTE/S FOR CONDITION:

The primary role of this condition is to confirm the approved plans and documents that form the planning decision. Any document or plan not listed in this condition is not approved,

The second role of this condition is to allow the potential process of Non Material Amendment if found necessary and such future applications shall be considered on their merits. A phasing plan submission via this condition is optional and not a requirement.

Any indication found on the approved plans and documents to describe the plans as approximate and/or not to be scaled and/or measurements to be checked on site or similar, will not be considered applicable and the scale and measurements shown shall be the approved details and used as necessary for compliance purposes and/or enforcement action.

8. Informatives

Positive and Proactive Statement

The Local Planning Authority has acted positively and proactively in determining this application by assessing the proposal against all material considerations, including planning policies and any representations that may have been received and subsequently determining to grant planning permission in accordance with the presumption in favour of sustainable development, as set out within the National Planning Policy Framework.

9. Equality Impact Assessment

In making this recommendation/decision regard must be had to the public sector equality duty (PSED) under section 149 of the Equality Act 2010 (as amended).
