Request for Consent to gain Exemption from Call-in Procedure.

I propose to make the following executive decision:-

- (a) The Council confirms the Council's participation in an All Essex Business Rates Pool in 2018/19 and supports the application to the Government to become a pilot area in the same year;
- (b) delegation be given to officers to continue to work with the other Local Authorities in the Pool to develop the final pooling agreement and application to become a pilot area;
