**PART 1 – KEY INFORMATION**

**PURPOSE OF THE REPORT**

To seek authority to proceed with the formal naming of the roads currently under construction Foots Farm site, Land South of Centenary Way, Clacton-on-Sea, Essex.

**EXECUTIVE SUMMARY**

A new development of 122 properties and 10 new roads has commenced on the site at the above location. The layout of this development is shown on the drawing attached as an Appendix to this report.

However, if the Council objects to the proposed names, the person proposing the name may appeal against the objection to a Petty Sessional Court, under Section 17 of the Public Health Act 1925.
