# 7. Officer Appraisal (including Site Description and Proposal)

# **Application Site**

The application site is located on the south-western side of Colchester Main Road and consists of a detached bungalow, which faces north-east. The site is separated from the highway via a low fence behind which shingle encompasses the front garden. The rear garden is a mix of hard and soft landscaping which is enclosed on all sides by fencing and mature dense hedgerow.

#### **Proposal**

This application seeks planning permission for a single storey rear extension.

#### <u>Assessment</u>

The key considerations of this application will be Design and Appearance, Impact upon the Neighbours and Other Considerations.

#### Design and Appearance

The development is located to the rear of the site and will be screened by the bulk of the main dwelling. The proposed rear extension measures 10.4m in width, 5.0m in depth and has an overall height of 3.0m. The site is considered to be of a sufficient size to be able to accommodate the proposals and still retain adequate private amenity

The proposed rear extension is single storey with a flat roof, finishing just above the eaves of the host dwelling. A roof lantern will be installed in the middle of the roof. The proposals will be finished in cladding which differs to the current appearance of the host dwelling but will match the existing

outbuilding. Nevertheless, the property still retains its Permitted Development Rights and the extension could be clad at a later stage without first needing planning permission.

A window on the south-east facing side elevation will be replaced for a door and window set, whilst an opening on the north-west facing side elevation will be bricked up. As these works are deemed Permitted Development they do not require planning permission and therefore have not been assessed as part of this application.

#### Impact to Neighbours

The proposals is single storey in nature with no openings on the either of the side elevations of the proposed extension. Additionally, it has a separation distance of 6.4m from the extension to the closest neighbouring dwelling and will be heavily screened by the existing fencing and dense mature hedgerow. The extension's height is also limited to 3.0m and as a result, the proposal is considered to pose no demonstrate harm to the amenities of the adjacent neighbouring properties.

#### Other Considerations

Alresford Parish Council made no comments on the proposal.

No letters of representation have been received.

#### **Ecology and Biodiversity**

# General Duty on all Authorities

The Natural Environment and Rural Communities Act 2006 amended by the Environment Act 2021 provides under Section 40 the general duty to conserve and enhance biodiversity: "For the purposes of this section "the general biodiversity objective" is the conservation and enhancement of biodiversity in England through the exercise of functions in relation to England." Section 40 states authorities must consider what actions they can take to further the general biodiversity objective and determine policies and specific objectives to achieve this goal. The actions mentioned include conserving, restoring, or enhancing populations of particular species and habitats. In conclusion for decision making, it is considered that the Local Planning Authority must be satisfied that the development would conserve and enhance.

This development is subject to the general duty outlined above. An informative has been imposed strongly encouraging the applicant to improve the biodiversity of the application site through appropriate additional planting and wildlife friendly features. Therefore the development on balance, with consideration of the impact of the development and baseline situation on site, is considered likely to conserve and enhance biodiversity interests.

## **Biodiversity Net Gain**

Biodiversity net gain (BNG) is an approach that aims to leave the natural environment in a measurably better state than it was beforehand. This excludes applications for Listed Building Consent, Advert Consent, Reserved Matters, Prior Approvals, Lawful Development Certificates, householders, self builds, and other types of application which are below the threshold i.e. does not impact a priority habitat and impacts less than 25 sq.m of habitat, or 5m of linear habitats such as hedgerow). This proposal is not therefore applicable for Biodiversity Net Gain.

#### Protected Species

In accordance with Natural England's standing advice the proposed development site and surrounding habitat have been assessed for potential impacts on protected species. It is considered that the proposal is unlikely to adversely impact upon protected species or habitats.

#### Conclusion

In accordance with the overarching duty outlined above, this development is considered to accord to best practice, policy, and legislation requirements in consideration of the impacts on ecology interests. Further, the proposed development is consistent with the above mentioned national and local planning policies and, in the absence of material harm the proposal is recommended for approval.

REASON: To comply with the requirements of Section 91 of the Town and Country Planning Act 1990 as amended by Section 51 of the Planning and Compulsory Purchase Act 2004.

#### NOTE/S FOR CONDITION:

The development needs to commence within the timeframe provided. Failure to comply with this condition will result in the permission becoming lapsed and unable to be carried out. If commencement takes place after the time lapses this may result in unlawful works at risk Enforcement Action proceedings. You should only commence works when all other conditions requiring agreement prior to commencement have been complied with.
