Decision Made:	To accept the recommendation of the Housing Ombudsman in respect of a complaint investigated and determined by it – including to authorise a payment in the sum of £300 to the tenant concerned (reference 202302247).
Reason for Decision (if a report was produced to support the Decision, refer to or attach it):	There had been service failure in the landlord's handling of the complaint, for the time, trouble distress and inconvenience caused by the landlords ineffective complaint handling. The recommendation from the Housing Ombudsman that a payment in the sum referenced be made to the tenant. The recommendations have been accepted.

Details of any Alternative Options Considered and rejected (together with reasons):	The non-payment of the proposed sum was considered and rejected as an option. The Housing Ombudsman investigation determined the extent of the service failure and has independently evaluated the extent of payment to the tenant. The recommendations have been accepted in full and, consequently, the Council's agreement with the Housing Ombudsman could not be fulfilled without making the payment concerned.

Reasons: The Council has given undertakings not to disclose the detail of the tenant in public. These undertakings are deemed important to the Housing Ombudsman's role in independently considering complaints and the freedom of individuals to raise concerns without the prospect of their details being placed into the public domain. An anonymised report summarising the issues involved in this case will also be reported to the Cabinet in due course to support learning in respect of the matters addressed in the complaint. This learning is considered to represent the wider public interest in this matter.
