I am writing to formally **object** to the application for an alcohol license for the family visitor attraction located within our residential estate, Wyvernwood. My concerns are grounded in several key issues that I believe warrant serious consideration under the Licensing Act 2003.

- 1. **Family-Centric Nature of the Attraction**: This attraction is designed specifically for families with children aged 2-12. It is completely inappropriate for the premises to serve alcohol, especially from 9 AM, when even pubs typically do not start serving until later in the day. The presence of alcohol in an environment focused on family activities contradicts its core mission and may create a mixed atmosphere that could negatively impact children and their parents.
- 2. Residential Context and Risk of Anti-Social Behavior: The attraction is situated within a residential estate, where many private residences are in close proximity. The addition of alcohol service poses a significant risk of anti-social behavior, crime, and property damage. According to the Essex Police data for postcode CO7 8ES in August, there were alarming statistics: 80 incidents of Violence and Sexual Offences, 16 Criminal Damage and Arson offences, 12 Public Order offences, and 10 Theft offences. Notably, there was a previous incident of arson at Wyvernwood, where someone attempted to burn down the castle. This serves as clear evidence of the risk of serious crime in the area, posing a direct threat to life and safety. Granting this license could exacerbate these issues, putting the safety and wellbeing of local residents at considerable risk.
- 3. Safety Hazards from Alcohol Consumption: The estate features a busy road, and the potential for visitors under the influence of alcohol poses a grave risk to both pedestrian safety and vehicular traffic. There is no lighting whatsoever on any of the roads within the estate, including the internal residential roads and the access road from the B1027. This lack of illumination significantly increases the likelihood of accidents, which could lead to serious injuries or fatalities.
- 4. **Protecting Children from Harm**: A specific criterion of the Licensing Act is to protect children from harm. This attraction caters primarily to families and young children and includes physical play equipment that could lead to serious injuries if a fall occurs. If parents or guardians are not in a fit state to monitor their children's wellbeing due to alcohol consumption, the risk of accidents increases significantly, compromising the safety of the very demographic the attraction aims to serve.
- 5. **Risks from B1027**: The access road to the attraction is from the B1027, a high-speed road where the encouragement of alcohol consumption could result in serious road traffic accidents. This poses a significant threat to the lives of visitors, their children, and

other users of this busy road. According to Essex County Council, there have been 7 fatal road traffic accidents on the B1027 since September 2019. Allowing alcohol on the premises could exacerbate this already dangerous situation.

6. **Impact on Local Residents and Work Environment**: Local residents work from home and rely on a peaceful environment to conduct their daily activities. The attraction has previously received public nuisance complaints. Allowing alcohol consumption would likely lead to increased noise, litter, public nuisance, and further degradation of local amenity, which would be unacceptable for those living in the vicinity.

Given these concerns, I urge the licensing committee to reconsider the application for an alcohol license for this family visitor attraction. The potential risks to children, local residents, and overall community safety are too great to overlook.

Granting this license could exacerbate these issues putting the safety and well-being of local residents at considerable risk.

3. Safety Hazards from Alcohol Consumption Wyvernwood is on a busy road and the potential for visitors under the influence of alcohol poses a grave risk to both pedestrian safety and vehicular traffic. There is no lighting on any of the roads within the estate or the access road from the B1027. This lack of illumination significantly increases the likelihood of accidents.

4. Protecting Children from Harm

A specific criterion of the Licensing Act is to protect children from harm. This attraction caters for families and young children and includes physical play equipment and serious injuries could occur if children were not properly supervised.

I urge the Licensing Committee to reject this application given the potential risks to children, local residents and the overall community.

Objection to proposed Premises license

Wyvernwood is a seasonal attraction catering to young families with children aged 2-12. The current Premises application seeks permission to sell alcohol from 9am-9pm, year-round, i.e. all day, every day, anywhere across the site.

Granting the license on this basis creates unacceptable risks to local residents, and would likely lead to direct breaches of the four licensing objectives. Furthermore the application is out of keeping with the characteristics of a family visitor attraction.

Our primary concerns around a Premises licence being granted to Wyvernwood are the following:

1) Public nuisance: our property is located adjacent to the field between the "Dragon Trail" and "Castle Grounds" areas of the attraction. We have previously been affected by visitors shouting and screaming, and by amplified noise. The granting of such a wide ranging Premises licence is of particular concern as we frequently work from home. Alcohol consumption will create further public nuisance with additional noise, litter, and general disturbance. The licence as proposed will negatively impact our ability to work from home, and further damage residential amenity.

2) Anti-social behaviour: our property is located in the heart of the Alresford Hall estate (a semirural location shared by c.10 private residences as well as the attraction). The licence as proposed has no restrictions as to where alcohol will be able to be served and consumed within the attraction, and therefore it creates an unacceptable risk that we will be exposed to antisocial behaviour such as vandalism, theft, arson, etc.

3) Public safety: The vast majority of visitors visit the attraction via private car. Access is via the busy B1027. Encouraging the use of alcohol is likely to lead to further road accidents and risks fatalities.

We are seeking a reasonable balance between the attractions desire to serve alcohol to visitors vs. the potential negative impact on local residents and our environment. The following restrictions should be in place at a minimum:

i) alcohol only to be served 12-5pm, on days when the attraction is open - to ensure that residents are not exposed to endless public nuisance. It cannot be right that the attraction is able to serve alcohol all day, every day, there have to be reasonable constraints to protect residents

ii) alcohol only to be sold and consumed in the main "Castle Grounds" site, monitored by staff to minimise the public nuisance impact, ensure the safety and welfare of visitors and their children, and mitigate against anti-social behaviour and crime risks. The attraction has very few physical barriers between the site and residential areas - visitors under the influence of alcohol are much more likely to leave the designated attraction areas (this already happens), exposing residents to Public Nuisance, anti social behaviour and Crime

3) visitors are not able to bring their own alcohol, only the attraction can sell and serve alcohol - to ensure visitors are behaviour appropriately and their wellbeing can be monitored by staff

In summary, the application in its current form would enable the applicant to serve alcohol all day, every day, anywhere across the site. This is unacceptable to local residents, and there needs to be reasonable restrictions that balance the rights of residents and the requirement to satisfy licensing objectives vs the commercial ambitions of the attraction.

To the Licensing Committee,

Wyvernwood's application for a Premises license is of great concern to us and in our view in contradiction to many of the licensing objectives.

An additional area of significant concern is that with a standard Premises license, the attraction would have an exemption that will allow them to play live and amplified music, without requiring further permission.

This creates an intolerable risk to residents with regards to public nuisance and noise pollution. The attraction is wide ranging, and covers an area including the main "Castle Grounds" site as well as open fields where private residences are located and leading up to Alresford village (Wivenhoe Road).

If the attraction had the ability to amplify noise with no restrictions on the location of where it could be amplified from and the times (beyond the standard inadequate constraints), this would cause significant public nuisance. As the attraction is outdoors, there is no sound barrier at all.

The last time that the attraction amplified noise outside of the main "Castle Grounds" site, this caused us significant disturbance. The noise was so loud during the day, it could easily be heard inside even when all windows were closed, it ruined our ability to take calls while working from home, and caused significant distress to our pets - video evidence attached.

To summarise, if there are not significant restrictions on the license with regards to its ability to create noise pollution this will wreck our ability to work from home and enjoy our lives and it would be a clear contravention of the license objective to avoid public nuisance.

As residents on the perimeter of Wyvernwood Ltd amusement and theme park I am concerned and would like to voice my objections regarding the recently applied for premises licence.

The area is a place for families to come and visit with their children, meet like minded people and for the children to interact with each other and also the park characters. The need to provide alcohol would seem to me to be in direct conflict with what the area is supposed to represent. A fun family day out doesn't require alcohol to be available to adults accompanying their children. I feel that to grant such a licence negates the ethos of the experiences portrayed and offered by Wyvernwood.

I would suggest that the provision of alcohol would provide for

1 - An increase in the possibility of harm to children. An adult having consumed alcohol is in a less stable position to properly supervise and ensure the safety of children in their care. It is a known fact that alcohol impairs reaction times, which need to be very quick in the case of children playing on the park attractions, and walking through the woods just by way of an couple of examples.

2 - Once alcohol is consumed inhibitions and common sense diminish. The residents surrounding the park are at greater risk of visitors to the park causing a nuisance by trespassing onto their properties and not adhering to the parks designated areas. The homeowners in the direct vicinity will be at greater risk of unwanted visitors interfering with their right to peace, quiet and privacy. The availability of alcohol so early in the day could potentially attract the wrong kind of visitors to the play area who would be coming for the alcohol alone.

3 - With alcohol the risk of crime is considerably increased. As there are residential properties directly adjacent to the park, the risk of trespassing increases, as reason and common sense diminish following the consumption of alcohol. This could in turn lend itself to vandalism, theft and criminal damage which is an unacceptable increased risk.

4 - The park cannot easily be accessed on foot (there is no direct footpath) therefore all visitors (or the vast majority) will be visiting by car. As a population we are told to not drink and drive, so why would alcohol be necessary at a children's play area that is largely only accessible by car. The children cannot drink, it is only the accompanying adults who can, and they have to drive the children home at the end of their visit.

The hours requested under the application from 9am to 9pm covering the whole area are excessive. Why would drink need to be available first thing in the morning before the park is even open (excepting the very odd occasion at Christmas)? Even pubs cannot serve alcohol before 11.30am, at the very earliest, so why would a children's play area need to?

A premises licence authorises the use of any premises for licensable activities defined under the licensing act 2003. It is my strong belief that the request for a licence is a precursor for other events to be held on the premises, not those related to children and the play area. Any other activities requiring a premises licence would be totally in conflict with the area and the surrounding properties having a detrimental effect on their quality of life and in addition the value of their properties. Noise carries, and other events such as concerts would be heard in surrounding areas.

Above are the primary reasons why I believe that there is no need for a premises licence to be granted to Wyvernwood Ltd. Any financial gains to them as a children's theme park are negligible in comparison to the increased risks to not only local residents, but in addition the general public, once a driver gets behind the wheel of a car having consumed alcohol. "Don't drink and drive!"

07/11/2024 2:02 PM Following the meeting of November 6th 2024, it was proposed seconded and carried by councillors present unanimously to suspend non statutory standing orders unde S-10A subsection 15, Standing order S9B was suspended to

allow the matter of application 24/00581/PREMGR to be debated by full council, which was not included on the published agenda.

Council proposed to Object to the application as submitted, this was carried by 9 votes for, 1 abstention.

Councillors questioned the venues requirement for 9am to 9pm opening, the sale of alcohol at a venue in which public transport links are at best limited, whose primary market target is for 2yr olds to 12yr olds.

Council were surprised there had been no prior dialogue or consultation, and asked why 365 days a year were being sought or required.

Councillors made comparison with other venues in the region whose demographic is wider and whose location allows for other events to take place; questioning if this was an application to precede changes of use and working hours?

Specific points made against the three above criteria were:

The application appears to encourage drink driving - a Public Safety issue; that with the age of the children the venue supports - protection of Children from Harm - is there a wider agenda relating to change of use and events being run; the blanket 365 day 9am until 9pm application was worrying -Opening Hours.

Councillors made comparisons with public house brewery chains offering similar opening times and the clientele that these attract.

It was suggested that should the licence be granted that a compromise be sought through restrictions on days and hours of operation being placed onto the venue and applicant, either restricted to specific events being run, or later opening hours for the licence to be in operation such as 5-9pm.

I am writing to object to the application from Wyvernwood Limited for a Premises Licence for the Sale of Alcohol only from 9am until 9pm every day, at Wyvernwood, St Osyth Road, Alresford, Near Colchester, Essex, CO7 8ES.

My objections are based on my concerns that this new licence may increase the possibility of:

- 1. Child harm, and;
- 2. Public nuisance for the immediate and wider residential dwellings, and;
- 3. Crime and disorder, and;
- 4. Public safety.

1. Child Harm

Wyvernwood, whose policy is to accept two (2) to twelve (12) year olds, is a children's themed outdoor play park centred about an immersive story-led experience for families where visitors are encouraged to leave their worries behind when they step through a Magic Portal and enter a Magical Kingdom to experience an enchanting story about dragons, fairies, wizards, goblins, unicorns a captain and a princess.

Permitting alcohol to be sold at an attraction aimed solely for the enjoyment of 2 - 12-year-olds is not in keeping with the intended purpose and has the potential to cause child harm.

Young children may be put at risk if they are not properly supervised and/ or are exposed to adults who have become intoxicated, thereby placing them in danger, for example from sexual predators and abuse from those who choose to exploit children.

Additionally, not only can children be dangerously intoxicated by quite small quantities of alcohol, older children within the maximum 12-year-old age bracket may also attempt to consume alcohol causing them to become vulnerable because their judgement is impaired – whether in the company of alcohol impaired adults, or not.

All children are at risk of adults who are viewed as a danger to them, and it is my opinion that adult "drinking" entertainment within the confines of a themed children's play park is not suitable for children and the application should be refused on this ground.

2. Public Nuisance

Of concern is the potential for further heightened noise nuisance to immediate and wider residential dwelling-holders.

Noise is already an intrusive issue for residents surrounding the **outdoor** play park and further afield, and whether tents/ other shelter structures are erected or not, noise travels easily.

The consumption of alcohol invariably brings with it raised noise levels, and the possibility of low-level disorder and the application should be refused on this ground.

3. Crime and Disorder

Drinking can lead to disruptive noise, which in turn can escalate into aggressive, violent or lewd behaviour, such as intimidation or verbal abuse, fighting or urinating in public.

All the above are offences which should not be witnessed by 2 – 12-year-old children.

Accordingly, the application for a licence to sell alcohol should be refused on this ground.

4. Public Safety

Wyvernwood is entered and exited from the B1027 close to a bend where vehicular traffic (motor cars, vans, lorries of all sizes) travel at speed. Whilst speeds of up to a permitted fifty (50) miles per hour (mph) may be the norm, the numerous accidents that have occurred along this stretch of road have, very sadly, resulted in fatalities through loss of control as a result of speeding or otherwise.

Drivers in charge of minors attending Wyvernwood, and who, should a licence to sell alcohol be granted, do consume alcohol, may drive with any level of impaired ability thus putting children's (and the general public) lives at risk.

The application for a licence to sell alcohol should be refused on this ground.

Wyvernwood is targeted to be of interest to children up to the age of 12 years old with opening hours and days restricted by its planning consent in 19/01856/FUL and 22/01306/VOC for the Schedule of Seasonal events dated 28th September 2022.

A licence valid for the the sale of alcohol of alcohol on the premises 9am-9pm every day is unreasonable, unnecessary and unacceptable.

Currently residents in the eastern section of Wivenhoe Road are subjected to shouting and screaming by adults (mainly male) in the wood, not their children. Allowing alcohol on site will further fuel these excitable fired up adults.

This application lacks any explanation for the reason for these hours and one can only assume that 9am to 9pm everyday is to allow for further increases in opening hours.

If it is deemed right to approve a licence it must be limited to the sale of alcohol on the open days and opening hours approved in the planning consent of 19/01856/FUL and 22/01306/VOC .
