Dear Councillor Placey

Concurrence with Officer Decision: Clacton Town Centre CCTV - Safer Streets Fund.

I write to seek your concurrence in respect of an officer decision to enter into a contract with OpenView Security Solutions Limited to Carry out upgrading an extension of the CCTV network in Clacton Town Centre.

On 22 December 2023 you decided as Portfolio Holder to accept the Safer Streets fund grant and to enter into a public consultation in order to embed compliance with the Council's CCTV code of practice. Subsequently your decision on the consultation results was combined with the final scope of the scheme and authority to progress with consents and contracts for the project.

Some divergence was noted between the scheme as determined upon and the procurement exercise previously completed. A new procurement exercise was recommended and has now been completed.

A further full, open, tender exercise was competed by our colleagues in the Essex Procurement Partnership and tenders received were evaluated both in terms of price (60%) and quality (40%) The successful contractor was OpenView Security Solutions Limited with a combined score of 90.91% (57.41% price and 33.50% quality) which just beat the next highest score which was 87.00%. OpenView's tender sum was £181,793.39 which is within the overall project budget and includes some provisional and contingency sums.

Accordingly, I propose to enter into a contract with OpenView Security Solutions Limited in the sum of £181,793.39 to deliver the extended and enhanced CCTV coverage in line with the Safer Streets Fund Grant.
