PART 1 – KEY INFORMATION

PURPOSE OF THE REPORT

To seek authority to proceed with the formal naming of the roads currently under construction Holly Farm (front), Main Road, Frating, Colchester, Essex.

EXECUTIVE SUMMARY

A new development of 5 properties and 1 new road has commenced on the site at the above location. The layout of this development is shown on the drawing attached as an Appendix to this report.

RECOMMENDATION(S)

(a) That the new road shown on the site plan attached as an Appendix to this report is named: - “Holly Farm Close”

*Reason: -
Holly Farm Close (Reason): Because the existing dwelling that is currently being demolished was previously named “Holly Farm” and the developers would like this reflected in the name.*

That all interested parties be advised of the names allocated to the new roads.
