To pay the Shopfront Improvements grants that have been approved from funds allocated to them from Ten_08 of the Community Regeneration Partnership for approval by the Portfolio Holder for Economic Growth, Regeneration & Leisure. The Community Regeneration Partnership, is a government programme which through delivery of 15 projects, aims to address key socio-economic challenges in Clacton-on-Sea and Jaywick Sands, improve local infrastructure, enhance community services, and contribute to the long-term regeneration of the area. On 20 December 2024, Cabinet approved the recommendation to allocate £0.5m capital expenditure from the Community Regeneration Partnership to the Shopfront Improvements project (Ten_08) and on the 14 November 2025 Cabinet approved the recommendation to allocate an additional £200,000 Capital to the Ten_08 Jaywick and Clacton Shopfront Improvements project, and on the 4th March 2026 £28,252.00 has been allocated from the underspend in project Ten-02 raising the total project	Not to pay the grants as soon as possible, which may lead to them not being completed within a reasonable timeframe. To allow the continuation of the grant payments, bids for the grant are required to be approved and scored by the Project Board and due diligence is carried out to ensure the bids are appropriate and are within the terms and conditions of the grant. The decision for the grant is compliant with the External Grant Funding Checklist. 58 Shopfront improvement grants have been provisionally awarded by the Project Board, within the designated area of Clacton, Holland-on-Sea and Jaywick as specified by the Ministry of Housing, Communities and Local Governments (MHCLG) Community Regeneration fund.
