**NOTE:** At the final meeting of the Service Development and Delivery Committee held on 4 April 2018, Committee Members considered, amongst other things, what items,

if any, to put forward for inclusion in the 2018/2019 Work Programme for the new Resources and Services Overview and Scrutiny Committee.

One of those items put forward was “**Review of Tendring Closed Road Rally 2018**”. That item was duly included in the 2018/2019 Work Programme for the Resources and Services Overview and Scrutiny Committee that was submitted to, and approved by, the Annual Meeting of the Council on 24 April 2018.

The Monitoring Officer has pointed out that this item, due to the fact that the Road Rally was not a TDC event, should actually be on the Work Programme for the Community Leadership Overview and Scrutiny Committee as the Rally involved TDC working with external bodies (Essex Police, rally organisers, public etc.) on matters such as community safety.

Therefore this item has now been removed from the Resources and Services Committee’s Work Programme and reallocated to the Community Leadership Committee’s Work Programme.
